#### 1. Introduction and Status Review

### 1.1. Approval of Minutes (25 October 2018)

The minutes from the previous meeting were approved.

#### 2. Review of Amended modification

Bob Fletcher (BF) informed the Workgroup that an equivalent IGT Modification is to be developed in parallel which is currently work in progress. At this stage the intention is not to have a joint Workgroup as IGTs want to understand the impact on their Code in the first instance.

Richard Pomroy (RP) stated that he is to make a decision on what is needed to amend this Modification particularly, in relation to the need for a transition period. The Workgroup suggested that a lead time of 12 months is needed between Modification approval and implementation as this would allow time for meter reading contracts to be put in place. In addition, a 3-month transition period would be helpful.

Dave Addison (DA) confirmed that system changes are also needed and Xoserve are targeting the June 2020 release, therefore, a decision by June 2019 is needed.

Workgroup agreed to defer further consideration to the December meeting.
