1. Introduction and Status Review

Bob Fletcher reminded Workgroup that this is a joint workgroup with the IGT UNC Workgroup 0116.

1.1. Approval of Minutes (25 October 2018)

The minutes from the previous meeting were approved.

2. Consideration of Amended Modification

Kirsty Dudley (KD) explained that the Modification had been amended to only provide permissions for a new *User Type* (Alt Han Company) and to align the IGTUNC Modification 116.

In response to a question from Shanna Key (SK), she confirmed that Modification 0649S - *Update to UNC to formalise the Data Permissions Matrix* has formally created the Data Permission Matrix as part of the UK Link Manual. Modification 0649S requires that the addition of a new User type (a new party to be recognised on the Data Permission Matrix) is undertaken by a UNC Modification. Once the new User type is created the approval for the release of data to the new User type is held by the Data Services Contract (DSC), Contract Management Committee.

In response to a further question, she also confirmed that the privacy impact assessment (PIA) would be undertaken through DSC Contract Management Committee as well as decisions on the options/data to be provided.

A brief debate then took place on the Data Permissions Matrix provided for discussion at the meeting. It was reiterated that this is not a change to the UNC but part of the UK Link Manual. BF queried if there is a requirement for Legal Text change to the UNC or is the Data Permissions Matrix the Legal Text?

Richard Pomroy (RP) suggested that a change would be needed to UNC Transportation Principal Document (TPD) Section V – General (5).

David Mitchell (DM) confirmed that work on the Legal Text will commence when the Modification has been finalised. The Workgroup agreed that a Alt Han Company would need to be added to TPD Section V5.

Kirsty Dudley agreed to amend the solution section of the Modification to make it an explicit requirement for Alt Han to be included in TPD Section V.

3. Review of questions/queries sent to the DSC Change Management Committee

Richard Johnson (RJ) informed the Workgroup that he had received some queries but many of them are no longer relevant following the implementation of UNC Modification 0649 and this Modification has been subsequently amended to reflect the changes.

4. Development of Workgroup Report

Deferred to the next meeting.

5. Review of Outstanding Actions

Action 1001: E.ON (KD) to replicate the reasons for each data item within the Privacy Impact Assessment (PIA) Document.

Update: BF confirmed that this is now part of the DSC Change process, so this action can be closed. **Closed**

Action 1002: E.ON (KD) to amend the Modification and the Business Rules in relation to the sharing categories.

Update: The Modification has been amended and published so this action was closed. **Closed**

Update: RJ confirmed that he had received some queries which he had responded to. Workgroup agreed that this action could be closed. **Closed**

6. Next Steps

BF confirmed that the focus of the next meeting would be to review the amended Modification, review the Legal Text (if available) and to conclude the Workgroup Report.

Dave Addison (DA) indicated that Xoserve timetable means that the DSC Contract Committee would need to approve the Data Permissions Matrix at the February meeting. The tight timescales might mean that conditional approval is sought in advance of the approval of this Modification and that this had been done before. KD stated that the DSC Contract Committee had discussed this Modification at this month's meeting so some of the preparation work was in already in place, but a further discussion would be needed when the detail was available.
