## 1.1. Approval of Minutes (23 September 2019)

The minutes from the previous meeting were approved.

#### 2. Amended Modification

RK confirmed that the Modification had been amended mid-October and was now at v3.0. He summarised the changes and confirmed that the data items within Section 5 were not provided for the provision of Legal Text; they were provided for clarification only.

Following the amendment, it was anticipated that the Legal Text could now be produced for the Modification.

New Action 1001: Legal Text to be provided for Modification 0690S v3.0.

The impact on IGTs was briefly considered and whether a separate IGT UNC carve out would be required or a reference to the UNC. KD expressed concern that there is a general lack of cross code co-ordination. FC explained that certain sections of the IGT UNC simply point to the UNC and other areas are carved out. It was understood for some Modifications it can be difficult to understand if there is an impact on the IGT UNC until the legal text has been produced for the UNC.

RK confirmed that the IGTs needed to be included within the scope of the Modification and he would review the IGT UNC to ascertain if a Modification was required. It was agreed that if an IGT Modification was required an IGT Modification will be raised by British Gas.

**New Action 1002:** British Gas to consider whether an equivalent IGT Modification is required and update Modification 0690S if necessary.

The Rough Order of Magnitude (ROM) had already been requested and no costs had been identified.

#### 4. Confirmation of whether an equivalent IGT Modification is required

RK believed there would be a requirement for a corresponding IGT Modification. See item 2.0.

**Update:** RK confirmed he had listed the data items within the Change Proposal and agreed to discuss these at the 25<sup>th</sup> October PAC-related workshop, led by the PAFA (not a UNC-led Meeting). **Carried forward.** 

**0902:** PAC Members (CW/LH/MB) to ensure the specification of the new PARR Reports for Modification 0690S is considered by the Performance Assurance Committee (PAC). **Update:** PAC members to ensure the specification of the new PARR Reports for Modification 0690S is discussed on 25<sup>th</sup> October. **Carried forward.**
