#### 1. Introduction and Status Review

The meeting was confirmed to be quorate.

## 1.1. Approval of Minutes (22 October 2019)

The minutes from the previous meeting were approved.

## 2. Amended Modification v6.0

Stephanie Clements (SC) provided an overview of the changes within the amended Modification and drew attention to specific areas of interest in relation to the Business Rules and the associated timetable alterations.

A brief discussion took place as to whether Smart Meters were a defined term or not. Andy Clasper (AC) and Louise Hellyer (LH) concurred that they did not think it was and LH added that within Modification 0692S, it wasn't referred to as defined term.

Fiona Cottam (FC) sought clarity in relation to Business Rules 1. a, b and c regarding the monthly read for sites >293,000 that do not have Smart Meters, SC said that the >293,000 should be regardless of the equipment so she would be take out the wording "Smart and AMR" to provide clarity.

SC confirmed that there were no more alterations or changes proposed to the Modification content and that the final amended Modification would be v8.0.

#### 3. Consideration of ROM Request

James Rigby (JR) and FC said the ROM had been delivered on 18 November 2019 and SC confirmed the changes were reflected in the ROM.

## 4. Consideration of PARR Report specification/format

A general discussion took place in relation to PAC Document 8 – targets and all agreed it should have a specified title, Mark Bellman (MB) proposed it should be referred to as the; 'Performance Assurance Targets Report' and that this matter would be discussed and confirmed at the next PAC meeting to gain agreement from the PAC Members.

A brief discussion took place in relation to the governance of this document 8 and whether that would be encompassed under TPD section 12 in the UNC. MB said that each associated Modification needed to have the Document 8 included within in it from a continuity perspective. Richard Pomroy (RP) suggested that Document 8 was governed by the PAC as per the Performance Assurance Framework and Rebecca Hailes (RH) enabled Workgroup to view the Performance Assurance Framework document on screen to aid understanding.

**New Action 1101:** ScottishPower (SC) to include the sample Document 8 into the Modification with reference to TPD section 12 with the proposed draft name of 'Performance Assurance Targets' including the relevant governance.

#### 5. Consideration of System Changes

SC confirmed that there should be limited central systems impact other than the provision of the new reporting.

#### 6. Legal Text provision and review

AC said that the Legal Text had been drafted and that discussions had been taking place with both ScottishPower and Xoserve and would be completed once the final amended Modification v8.0 had been submitted.

He added that the timing was very tight in view of the fact the formal 15 days ended on 12 December 2019 and he said he would arrange a teleconference with Cadent and Dentons, as soon as the amended Modification was available. RH said that a further extension could be requested from Panel, if that became necessary.

**New Action 1102:** Joint Office (RH) to record an update regarding the Legal Text in with the Workgroup Report for review at the December meeting.

## 7. Confirmation of whether an equivalent IGT Modification is required

SC said that she did not think an IGT Modification would be required, however she added that this could only be formally confirmed once the Legal Text had been finalised.

## 8. Finalise Workgroup Report

RH confirmed the Workgroup would be finalised at the December meeting.

Update: All PAC Members present agreed, and this action was closed. Closed.

**Update:** All agreed this action could be closed as the proposed title of Performance Assurance Targets Report was going to be submitted to the next PAC meeting for confirmation. **Closed**

**Update:** AC confirmed this action could be closed and the Legal Text would be updated once the amended Modification v8.0 was available. **Closed** 

Action 1006: Joint Office to request ROM for v6.0 Modification 0672.

**Update:** James Rigby (JR) and FC said the ROM was delivered on 18 November 2019 and SC confirmed the changes were reflected in the ROM. **Closed**
