1. Introduction and Status Review

The meeting was confirmed quorate.

1.1. Approval of Minutes 22 October 2019)

The minutes from the previous meeting were approved.

2. Confirmation of whether an equivalent IGT Modification is required

Rhys Kealley (RK) confirmed that an IGT Modification was not required.

3. Consideration PARR Report specification/format (November)

RK confirmed that the PARR Reporting had been discussed and considered and the reports would be all defined within related Modification - *Modification 0691 – CDSP to convert Class 3* or 4 meter points to Class 1 when G1.615 criteria are met.

4. Amended Modification (f IGT Modification required)

RK re-confirmed that an IGT Modification was not required.

5. Legal Text provision and review

RK noted that the way the month M is designated in Transportation Principal Document (TPD) Section G paragraph 1.6 means that a read from 11 months before the implementation date could lead to the conclusion that a move to Class 1 is required upon implementation.

A brief general discussion took place regarding the Legal Text and the Commentary and all agreed with the content. Rebecca Hailes (RH) said she would include these items within the Workgroup Report.

6. Finalise Workgroup Report

RH showed Workgroup the Workgroup Report and drew attention to specific areas of interest and explained that this Modification is related to Modification 0691S - CDSP to convert Class 3 or 4 meter points to Class 1 when G1.615 criteria are met.

RH proceeded to make some minor changes to the Workgroup Report in the meeting and all agreed that this was a self-Governance Modification.

Richard Pomroy (RP) said as the consultation period was during the Christmas period, he proposed this should be extended by 5 days to allow adequate time for the required consideration and submission of the representations. RH agreed with this suggestion and said she would propose this at the December Panel.
