The Workgroup Report is due to be presented at the UNC Modification Panel by 20 February 2020.

1.0 Outline of Modification

Alan Raper (AR) introduced the Modification and explained that it is looking to add the Performance Assurance Framework Administrator (PAFA) as a new User type to the Data Permissions Matrix (DPM). This process was originally included within Modification 0697S Alignment of the UNC TPD Section V5 and the Data Permissions Matrix. However, this element has now been separated from Modification 0697S to expedite its implementation.

Carl Whitehouse (CW), the proposer of this Modification suggested to the Workgroup that as it is introducing the PAFA as a new user type, based on previous discussions around Modification 0697, there may be some merit in debating which data items the PAFA should be able to see within the DPM.

AR clarified that, for the PAFA to be added as a new User, they would need to be added as a new column in the DPM. This will then enable the PAFA to request access to the data items

they require. Access to the data items is governed the DSC Contracts Management Committee (CoMC).

Dave Addison (DA) asked the proposer for clarity around what information the PAFA would like to review under this Modification. CW clarified the purpose of this Modification was to allow the PAFA to widen their reporting regime. Provision of this additional data will enable the PAFA to better understand the Performance Assurance Reports Register (PARR), and therefore, refine any actions as required.

CW further advised the Workgroup that this Modification was essentially extending the scope of Modification 0520 *Performance Assurance Reporting* which introduced additional reporting requirements for key industry inputs, affecting settlement allocation. However, the current information that the Performance Assurance Committee (PAC) receives is limited to PARR reporting. This Modification will address this issue as access to the DPM will provide the PAFA with additional information.

CW further advised the Workgroup that he will be approaching the IGT UNC separately for raising a related Modification.
