**Action 1101:** SM to liaise with AUGE to confirm the Gas Year to which the new table should apply.

**Update:** SM advised AUGE have concerns for an implementation effective from October 2020 for gas year 20/21. DA advised that Xoserve are concerned about impacts to Gemini, Xoserve are completing an assessment against the impact on file formats, at the moment it is thought there will be no changes. DA provided clarity that the current feeling is that, due to its complexity, this change may not be possible, but as yet, there is no documentation to support that view.

DA suggested the best way forward is to submit a ROM assessment, and to specifically ask within the ROM what the implementation date should be. He added that, with Gemini replatforming due in July 2020 and a further release due in September 2020, this change would need to be implemented with consideration of these events.

It was confirmed that the AUGE Statement procedure is in Uniform Network Code as a related document. **Action 1101 Closed** 

**New Action 1201:** Joint Office to raise a ROM requesting what the implementation date would be. cc DA and ER in the request.

**Action 1102:** Xoserve to provide detail on the system changes required to implement the proposal.

Update: The response for this action was submitted as part of Action 1101. Closed
