interference, and Shipperless and Unregistered sites. He explained that the Shipperless and Unregistered sites might need to be classified separately to be other TOG events.

DM advised that the Table requires an amendment to make it clear it is TOG and Shipperless sites should be separate, to make it clear to the reader.

DM advised the Modification will be amended and the legal text completed ready for review at the next meeting in February 2020.

When asked, DM confirmed that he will liaise with the proposer of the IGT equivalent Modification to ensure both IGT and UNC are reporting identically.
