UNC Variation Request

0697S – Alignment of the UNC TPD Section V5 and the Data Permissions Matrix

Date: 17 September 2020

The Proposer, Gazprom Energy, requests a variation to this Modification, pursuant to the Uniform Network Code (UNC) Modification Rules paragraph 6.5.1(c).

Reason for Variation

To ensure that the solution and intent of this UNC Modification aligns correctly with the intent of the BEIS (June 2020) amendments to UNC TPD Section V5.17.

Nature of Variation

The following amendments are proposed to the legal text contained within UNC TPD Section V, paragraph 5.17, in order to preserve the intent of the BEIS (June 2020) amendments (limited to the inclusion of new paragraphs 5.17.2 through to, and including 5.17.4).

Amend TPD Section V5.17 to read as follows:

5.17 Smart Meter Data Provision to Data Communications Company

- 5.17.1 Not Used. 5.17.1 The CDSP is authorised to disclose such data as is set out within Annex V-10 to the holder of the "smart meter communications licence" as defined by Statutory Instrument 2012 No.2400: The Electricity and Gas (Smart Meters Licensable Activity) Order 2012. Such data may relate to all Supply Meter Points regardless of status and includes Supply Meter Points which are located on the network of an Independent Gas Transporter where provided to the CDSP.
- 5.17.2 The CDSP shall, with effect from calendar month October 2020 onwards, provide to the holder of the "smart meter communications licence", the data, in respect of each Supplier, referred to in paragraph 5.17.3 by no later than the end of each calendar month (the 'relevant calendar month').
- 5.17.3 The data to be provided to the holder of the "smart meter communications licence" in respect of each Supplier is the number of Supply Points that relate to Designated Premises at which on the 15th day of the relevant calendar month:
 - (a) the Supplier is the relevant Supplier in relation to the Registered User at the Supply Point; and

- (b) the supply of gas is measured by an Advanced Meter.
- 5.17.4 For the purposes of paragraph 5.17.3:
 - (a) "Advanced Meter" has the meaning given to that term in the Supplier's Licence
 - (b) "Designated Premises" has the meaning given to that term in the Supplier's Licence.
 - (c) "Supply Point" includes a Supply Meter Point which is located on the network of an Independent Gas Transporter in respect of which the relevant data has been provided to or is held by the CDSP under and in accordance with the Independent Gas Transporters Uniform Network Code.
