SECTION V – GENERAL TERMS	
Amended paragraph 12.1.	To add the BPIR to the list of documents subject to governance as a UNC Related Document.
Amended paragraph 12.3.1	To make subject to new paragraph 12.3.2. <u>GT B4.3.2 should be read in</u> <u>conjunction with this clause. GT B4.3.2 states that "The Uniform Network</u> <u>Code Committee may by panel majority establish subcommittees (each a</u> <u>"Network Code Sub-committee" or, for the purposes of this</u> <u>paragraph 4, a "Sub-committee"</u>) for the purposes of doing or assisting in <u>doing anything to be done by the Uniform Network Code Committee"</u> . This means that where there is a UNC requirement that a sub-committee do something, it is a reference to the sub-committee established for the purpose of carrying out the relevant requirement.
New paragraph 12.3.2	To make clear amendment to the BPIR by UNCC contingent on recommendation for a change by the Contract Management Committee. <u>TPD V 12.4.1 should be read in conjunction with this clause. TPD V 12.4.1</u> <u>states that "In the event that the proposed modification is approved by a</u> <u>majority vote of the Uniform Network Code Committee, the modification</u> <u>shall be implemented."</u> - meaning that a modification to a UNC related <u>document requires UNCC and not a sub-committee approval.</u>

Amended paragraph 1.4.4	To require Parties (to Code) to take steps to ensure the CDSP incurs CDSP Costs in an efficient and economic manner.
Amended paragraph 3.1.3	To acknowledge the DSC Terms and Conditions are to ensure the CDSP incurs CDSP Costs in an efficient and economic manner.
Amended paragraph 3.3.1	To add to the matters to be addressed in the BCM the requirement the CDSP apply the BPIR when establishing the CDSP Budget for a Charging Year.
New paragraph 3.3.3	To require the BPIR to identify the minimum specified information categories to be used by the CDSP when establishing the CDSP Budget for a Charging Year.

Amended paragraph 4.7.3	To recognise there may be more than one revision of a draft CDSP Budget.
Amended paragraph 4.7.4	To recognise the Committee may require more than one revision of a draft CDSP Budget.
New paragraph 4.7.5	To require the CDSP to report on satisfaction of the required level of detail (as defined in paragraph 4.7.1) when sharing a draft CDSP Budget.
New paragraph 4.7.6	To identify what happens in the event the CDSP does not provide the required level of detail in relation to a draft CDSP Budget.
New paragraph 4.7.7	To provide for rules in relation to the availability of information in relation to a draft CDSP Budget in relation to which the CDSP may be subject to confidentiality restrictions.
New paragraph 4.7.8	To provide for rules in relation to the basis on which the CDSP may provide information on a redacted basis.
