## National Grid NTS Metering Charges from 1 April 2013

Please find attached a schedule showing National Grid NTS's revised metering charges to apply from 1 April 2013. National Grid NTS has calculated revised metering charges for those services that it is obliged to offer under its Gas Transporter Licence coupled with those services that are currently offered for historical / legacy purposes i.e. where a Datalogger or Converter has been fitted at an NTS Site or there is a maintenance requirement for an NTS High Pressure Meter Installation.

This notification is provided 2 months in advance of the effective date consistent with the notice period required under the Uniform Network Code.

It should be noted that following Ofgem's Review of Metering Arrangements, National Grid Metering initiated a consulted on metering charges. The consultation closed on 2nd November and following this National Grid Metering is developing initial pricing proposals, which are expected to be published shortly. These will be followed by final proposals in early 2013. Once this process has completed, it may be necessary to revise the prices attached to this note, subject to any licence conditions and contractual conditions.
