Ofgem publishes 2017 annual iteration process for energy network price controls

On 30 November, we published the 2017 annual iteration process (AIP) for energy network companies under our Revenue = Incentives+Innovation+Outputs (RIIO) price controls. The AIP updates base revenues across Ofgem's four price controls (for electricity distribution, gas distribution, electricity transmission, and gas transmission) for the next regulatory year (2018/19). 2017 Network Innovation Competitions Brochure

On 30 November 2017 we published our funding decisions for this year's Electricity and Gas Network Innovation Competition. For gas, we awarded £6.3 million to SGN to develop advanced robotics to automate and improve the utility excavation process. We also awarded £8.9 million to Cadent, NGN, SGN and Wales & West Utilities to provide safety evidence on whether the GB gas distribution networks are suitable to transport 100% hydrogen.
