1. Introduction and Status Review

Loraine O'Shaughnessy (LOS) welcomed everyone to the meeting.

1.1. Approval of Minutes (19 May 2020)

The minutes from the previous meeting were approved.

1.2. Approval of Late Papers

(LOS) said that the UIG Task Force Recommendations Tracker had subsequently been updated with a summary and so had been published late

1.3. Pre-Modification Discussions

No Pre-Modifications discussions took place.

2. Review of UIG Task Force Recommendations Tracker

Fiona Cottam (FC) provided a high-level summary as detailed below and explained that there were only 13 items left.

Summary

Background

FC explained that Unidentified Task Force (which Xoserve ran from September 2018 until March 2020) was set up to investigate the causes of Unidentified Gas (UIG) and were tasked with making recommendations to address the known causes of UIG. In total the Task Force made c. 95 recommendations, which were presented at meetings of the UNC UIG Workgroup.

Xoserve then tracked those recommendations through to closure, completion or awaiting sponsorship of a Modification.

Latest position

At the request of the UIG Workgroup in May, all recommendations were covered by an n-flight or approved UNC Modifications or closed down.

As at 19 May 2020 those remaining open recommendations were as follows:

Issue 12.2 (Use of a standard volume-to-energy conversion factor) - 9 options to address/mitigate the finding - Review Group 0693R continues to consider these options as part of its investigations

Issue 3.2.5 (Inaccurate / Out of date AQs) - 3 possible UNC Mods drafted, no sponsor identified; 1 possible UNC Modification - not yet drafted, no sponsor identified

FC reiterated that the UIG Taskforce Recommendations Tracker would be kept live and that she would be providing a communication once the UIG Workgroup was officially closed as to where and how this could be accessed in the future.

LOS said that in relation to the existing Workgroups; 0664 - Transfer of Sites with Low Valid Meter Reading Submission Performance from Classes 2 and 3 into Class 4, 0691S - CDSP to convert Class 3 or 4 meter points to Class 1 when G1.6.15 criteria are met, and 0693R - Treatment of kWh error arising from statutory volume-energy conversion, with the intention that both 0664 and 0691S are due to be submitted to the July 2020 Panel and that 0693R would subsequently move to the Distribution Workgroup in August. She said it was her intention to hold the 28 July 2020 UIG meeting in order to finalise both 0664 and 0691S.

Rhys Kealley (RK) questioned the level of UIG over the last couple of weeks and said that it was his understanding that the levels should have reduced and yet they were moving back towards -10 on an occasional basis and questioned this.

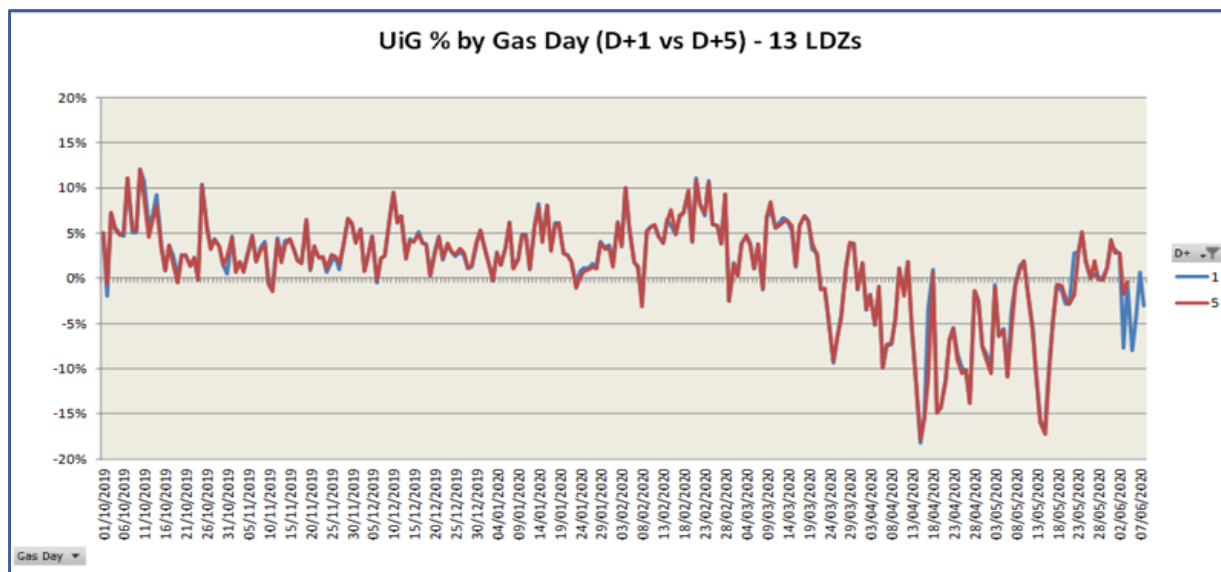
FC said that the UIG figure had turned negative during the second half of March due to COVID-19, as it was more like a Bank Holiday period because of increased demand during the enforced lockdown, which clearly had not been factored into the previous calculations. She added that this was the case for May also as there would normally have been a half Term Break, as this did not take place as a result of the pandemic. She said likewise, in late May the implementation of *Modification 0722 - Allow Users to submit Estimated Meter Reading during COVID-19* had taken affect at the point of allocation, which also had an affect.

FC advised Workgroup where they could find on the Xoserve Website, information pertaining to the UIG which is this could be accessed via the link:

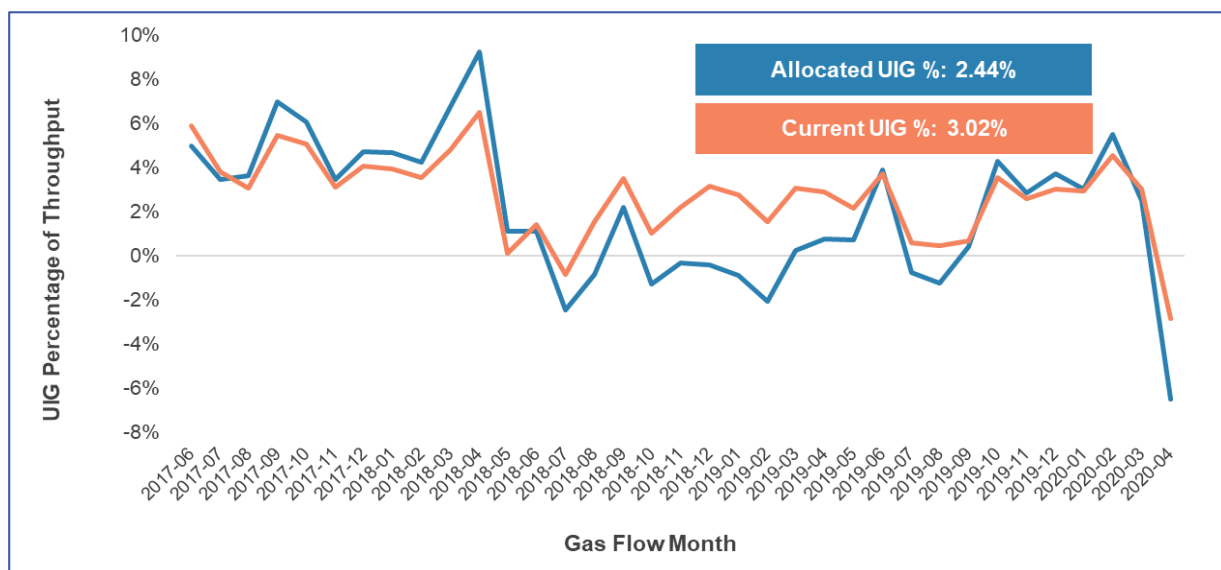

Update: FC and LOS said that once the UIG Workgroup was officially closed following the 28 July 2020 meeting then they would provide 'sign posting' communication regarding where the UIG Taskforce Recommendations Tracker information could be accessed. Closed. **Closed**
