

# Project Nexus Future State Legal Text (Transitional) Impact Tracking

## Introduction

### Background

In response to industry concerns around how best to track and assimilate changes to the Uniform Network Code text in light of the forthcoming implementation of Project Nexus [01 October 2015], the Joint Office has prepared a separate area within its web site where all legal text associated with the suite of Project Nexus related UNC Modifications can be found.

At the same time, this tracker report has been prepared which seeks to identify any 'closed' or 'in-flight' UNC Modifications that have an impact on, or are impacted by, the legal text associated with the Project Nexus related modification.

A 'closed' modification refers to a modification which has completed its full life cycle and has already been implemented into Code on any date that precedes the proposed Project Nexus 'go-live' date [01 October 2015]. *Please note, that these may comprise of transitional modifications that cease to be effective upon implementation of Project Nexus, or enduring modifications whose intention it is to remain effective after the Project Nexus go-live date.*

An 'in-flight' modification refers to any modification that has been signed off by either the Authority or the UNC Modification Panel (in the case of Self-Governance, or Fast Track Self-Governance modifications) which is the subject to a future effective implementation date which astrides the Project Nexus 'go-live' date. *Please note, that these may comprise of transitional modifications that cease to be effective upon implementation of Project Nexus, or enduring modifications whose intention it is to remain effective after the Project Nexus go-live date.*

Any modifications identified as having an impact on, or being impacted by Project Nexus will be colour coded as follows: **RED** will denote those modifications seeking an enduring solution beyond the Project Nexus go-live date, whilst **GREEN** will denote modifications that seek to provide a transitional solution upto the Project Nexus 'go-live' date and will thereafter cease to be effective.
