Proposer deferred tabling draft Proposal to a subsequent Workstream

Proposer presented two draft Modification Proposals for comment.

**The following were reviewed:**

- 003TR **Review of NTS Exit Capacity Arrangements**  
Ofgem gave a presentation on its consultation document: "Initial proposals on transitional incentive schemes supporting the offtake arrangements"
- 004TR **Emergency Arrangements**  
Ofgem explained its reasons for approving Modification Proposal 044 and for rejecting Modification Proposal 042. The Workstream concluded that the subject matter of the approved Proposal should be subject to the review procedures.  
E.ON UK presented a draft Modification Proposal which has been raised as Urgent Modification Proposal 052. Three Workstream meetings were arranged to discuss this Proposal and other aspects of this Topic  
The Proposer outlined Modification Proposal 050 and discussed the implications with the Workstream  
National Grid Gas Transmission submitted a draft review proposal, addressing the issues raised by Ofgem in its Decision Letter on Modification Proposal 021. The Workstream concluded that a specific proposal, rather than a review proposal was required.
- 005TR **Constrained Top-up**  
The Proposer requested that this Topic remain open.
- 009TR **Provision of Market Information**  
National Grid Gas Transmission gave presentations on Gas Balancing Alerts, improvements to its "Daily Outlook" web screens and a breakdown of costs associated with any implementation of Modification Proposal 006
