Transco April Maintenance Programme 2006

Transco is currently producing its April Maintenance Programme (AMP) for 2006 in accordance with Section L1.5 of Transco's Network Code. Upon completion it will be made available on the Shipper Information System and on Transco's Web site at www.uktransco.com.

In discussion with Shippers and connected parties, we have been asked to minimise potential disruption to the site by co-ordinating our maintenance activities with those of end users for the above period. I would therefore be grateful if you could complete the enclosed pro-forma with the timings of any planned site maintenance over the period 1st April to 31st October 2006 (inclusive). In order for this co-ordination to be successful, it is important that we receive this information as early as possible. I would be grateful if you could provide this information by no later than 25th November 2005. If your maintenance plans change after returning this proforma please advise us so that we can take this into consideration in our maintenance planning by submitting a revised proforma.

A draft of the maintenance plan will be published by 1st February 2006 and the definitive maintenance plan will subsequently be published by 1st April 2006. In response to feedback, and in addition to the maintenance plans Transco will also be advising shippers of their affected offtake points in writing by 1st February 2006.

Any subsequent amendments to the maintenance plan will be at Transco's discretion and may only be made under exceptional circumstances. Obviously, Transco will try to co-ordinate its maintenance activities with those of end users/CSOs where possible. Equally Transco would like to avoid periods where disruption to the offtake of gas causes particular problem to you/your customers.

However, this letter and your response to it in no way guarantees your expectations can be met, nor obliges Transco to co-ordinate its maintenance with that of end users/CSOs. It may be that where Transco is unable to co-ordinate its maintenance with that of end users/CSOs, the end user may wish to consider amending its own maintenance plans to match those of Transco.
