## **Notes**

In some cases the discussion on individual topics will be based around:

- a position paper (e.g. the paper on change control discussed on 21 March) which will be developed into legal drafting once the position and approach to the required UNC changes or DSC content has been agreed by the 0565 work group;
- in other cases the discussion can be based on legal drafting (e.g. changes to TPD Sections B, C etc or to EID).

Where a position paper or legal drafting is scheduled for discussion the aim is to circulate the paper or drafting [5] business days before the meeting (or earlier wherever this is possible).
