## **Rolling Monthly Transfer & Trade System Entry Capacity**

### **Invitation to participate in auction for capacity period August 2008**

Pursuant to TPD Section B2.3.10 of the Uniform Network Code, National Grid Gas plc invites you to take part in the Rolling Monthly Transfer & Trade System Entry Capacity (RMTTSEC) auction for the capacity period August 2008.

Please note this letter is notification of the first rolling monthly auction process implemented by Modification 187A and applies for August 2008 Firm Entry Capacity. It should not be confused with the final Rolling Monthly System Entry Capacity (RMSEC) auction invitation for July 2008 Firm Entry Capacity issued on 16<sup>th</sup> June 2008. Users are advised to make themselves aware of the changes made to the UNC by Modification 187A and seek advice from industry experts if unsure of what actions should be taken.

National Grid will conduct the auction on:

**7<sup>th</sup> July 2008**

The auction window will commence at 08:00 and close at 17:00 on the same calendar day. An RMTTSEC bid may be withdrawn or amended until, but not after 17:00.

The auction on this date will be held to allocate capacity for the following Capacity period:

**August 2008**

The amount of capacity to be offered for each Aggregate System Entry Point (ASEP) will be 100% of the unsold NTS Obligated Firm Entry Capacity plus any Firm Entry Capacity surrendered in the Surrender (Trade Initiation) process. This total capacity is termed the Available Capacity. The ASEPs where Available Capacity is to be offered, together with the unsold NTS Obligated Firm Entry

Capacity for those ASEPs, are shown in the attached Tables 2 and 3. The Initial Stage and Trade and Transfer stage of the auction are both pay as bid and the reserve prices that apply are specified in Table 4. Any unsatisfied bids after allocation of the Initial Stage (i.e. where bid quantity exceeds Available Capacity) will be analysed as part of the Transfer and Trade stage and allocations will be carried out subject to the relevant provisions of TPD Section B2.3 and the Entry Capacity Trade and Transfer Methodology Statement.

User allocations for the whole process (for the avoidance of doubt this includes the Initial Stage and the Transfer and Trade Stage) will be communicated no later than 3 business days prior to the last business day of July 2008.

Following RMTTSEC capacity allocation National Grid NTS will publish the aggregate information for each ASEP on the Capacity Auctions area of the National Grid Gas website under the **RMSEC link**. This can be accessed using the following link:

The RMTTSEC auction will be conducted in Gemini and any bids for NTS Firm Entry Capacity should be made using the **Deal>Capture>Create Bids** screen. Please be aware that if you wish to check your allocations from the February 2008 AMSEC auction prior to bidding in the RMTTSEC auction you should navigate to the following screen **Deal>Bid Capture Reports>Bid Information** screen in Gemini.

Please note that this message is being sent by e-mail via the Joint Office of Gas Transporters and web-fax (business hours operational list). An Automated Notification Service (ANS) message will also be issued informing users that the invitation has been published.
