1. Review of Minutes and Actions

2. Review Group Process

2.1 Allowed and Collected DN Revenue

This item had been covered under the immediately preceding DCMF meeting.

2.2 Completion of Final Review Group Report

TD reminded members that the group was due to complete the Final Review Group Report at this meeting in time for it to be submitted to the 15 May Modification Panel meeting. He suggested that the report might conclude that governance of the provision of cost information is sufficiently catered for via the DCMF in the immediate future, but that a Modification Proposal to create a governance

framework could be raised in future – either to formally constitute the DCMF or to create a UNC Related Document which specified the reporting requirements. SL indicated that he believes that governance of a UNC Related Document via the Uniform Network Code Committee would be preferable.

When asked, TD confirmed that UNC modification 0186 had not removed the Network Code 0698 NTS information provisions. He also confirmed that at present, amending the 0186 information provisions can only be undertaken via a Code modification.

SL enquired if the price change date within the table (as specified within Modification 0186), could be modified via a Consent to Modify request. GC did not see a problem with this as it resulted from a Licence change.

BK enquired the various 0186 DN Revenue Reports would be published. TD advised that these could be made available on the Joint Office web site at: http://www.gasgovernance.com/industryinfo/TransportationCharges/. The consensus was that these should be presented in Excel format, was and in a dedicated section of the website. MiB agreed to complete this prior to the next DCMF meeting.

The merits of raising a Modification Proposal to remove the 0698 information provisions were discussed, concluding that it was worth waiting to ensure that the 0186 provisions are working effectively. It was agreed that this should be on the agenda for the next DCMF meeting.

It was agreed that the final Review Group Report should be published on the Joint Office web site and presented to the Modification Panel, with any comments on the report to be sent to the Joint Office by 14 May..
