AR highlighted her concern that the information provided as a result of Network Code Modification 0698 "Requirement for Publication of Transco's Billed Charges against target" does not provide a clear indication of likely charge levels for the following year. Specifically it does not:

- 1. project the estimated allowed revenue; nor
- 2. indicate how allowed revenue is moving over time i.e. the over/under recovery effects of actual revenue versus allowed.

AR suggested that the main aim was to consider how information could be provided which would enable Shippers to take a view of the future path of Transportation Charges in the longer term, whereas Modification Proposal 0160 is looking at a short term solution.
