Key Points/Decisions

- 1. Joint Office welcomed everyone to the meeting. It was noted that at the start of the meeting the Workgroup was not quorate as there was not enough representation from Transporters.

- 3. Nick Wye on behalf of Gateway LNG Company presented to Workgroup a new alternative Modification 0621 proposal as a pre-modification discussion. The proposed alternative Modification is based on Modification 0621A with the key difference being a proposal to apply a 100% discount for Off Peak capacity at storage exit points. The justification for this is that that pipeline capacity is constructed and paid for by storage users through the acquisition of Firm Capacity, in particular Entry Capacity. The proposer considers that a combination of an 86% discount on capacity prices and a 100% discount for Off Peak capacity at storage Exit Points will result in an increased cost to non-storage Users of approximately £1.15m per annum in the

enduring regime. This would be recovered via an adjustment to the initial reserve prices. Joint Office informed the Workgroup that an extraordinary Modification Panel would need to be convened as soon as possible in order to consider the proposal as part of 0621 Workgroup. 4. The Workgroup Schedule was reviewed and the following changes were made to the agenda for Thursday 26 April 2018. The topic Reserve Price Specific Capacity will be discussed as part of the afternoon session and the NTS Optional Charge will be discussed as part of the morning session. In addition, the NTSCMF meeting to be held on 01 May 2018 will consider legal text for all the alternative Modifications (including the proposed alternative Modification 0621 if Modification Panel confirm this as an alternative and legal text is available). Joint Office informed the Workgroup that the Workgroup Report will be finalised on 8 May 2018. The Workgroup will see the final report before it is submitted to the Modification Panel. 5. Workgroup went through the *Workgroup Report Drafting* document published on the website as version 2.0. This document forms the basis of the discussion. The focus of the morning session was FCC and Historical Contracts (Page 4) and Revenue Recovery Charges (Page 6) in the transition period. The afternoon session focused on Revenue Recovery Charges in the enduring period (Page 7). 6. There are a number of other short topic areas which will be discussed when they can be slotted into the schedule. 2 topic areas were discussed at the meeting today: a. Multipliers (Page 5) b. Interruptible Capacity (Page 5). Through discussion Workgroup participants suggested amendments and comments which were noted in the document. The Chair acknowledged that the Comparison Table was an excellent source of reference which was used throughout the meeting as a comparison of the Modifications. Phil Lucas was thanked for his hard work to produce the document. An updated version of the table will be produced to take into account the new alternative Modification when it has been agreed.
