Key Points/Decisions

- 1. Joint Office welcomed everyone to the meeting.

- 3. No Pre-Mod discussion.
- 4. Chris Shanley talked the Workgroup through the proposed approach for Relevant Objectives explaining that the objective for the forthcoming Workgroup sessions on Relevant Objectives is to provide an assessment against all Relevant Objectives. There will be an opportunity for Workgroup to review this document, which can be found here: https://www.gasgovernance.co.uk/0621/270418, and to provide further views and evidence as part of the consultation process.

Highlighting the importance of version control for this document, he explained that the version of the Modification that is being considered, as part of this workgroup assessment, will be shown in Table one – summary of each Modification and the Proposer's assessment against each Relevant Objective. If time allows, if there is an amendment to any of the Modifications to the Relevant Objectives, then this document will be updated. Stressing the importance to the Workgroup, he advised Proposers to update and amend their Modification as early as possible, as there will come a time when the Workgroup Report will be assessed as being final.

The schedule for next week was reviewed, it was agreed that Treatment of Traded Historical Capacity would be discussed after Relevant Objectives on Tuesday 2 May 30 April. The NTSCMF meeting has a slight amendment to it, it is proposed that Proposers of Modifications meet with Dentons Lawyers from 9am to 11am on Tuesday 1 May, then the NTSCMF meeting will commence at 11am.

- 5. National Grid took the Workgroup through an onscreen view of the Impact of Optional Charge on Revenue Recovery Rates. Workgroup requested amendments and updates to be made to it, National Grid took an action to update the analysis ready for Monday 30 April. This completed the Analysis for the Alternative Modifications.
- 6. The Workgroup thanked National Grid for producing and finalising the analysis for all the Alternative Modifications.
- 7. National Grid showed the Workgroup through an onscreen review of the Optional Charge Impacts Under Recovery at Respective Points. National Grid will add some summary comments to the slide.
- 8. National Grid advised that in 0621D there is a coded y+5 Long Term Revenue Forecast and publishing it 4 times per year. It is noted that no other proposals are proposing to codify the production of a LT revenue forecast.
- 9. Penny Garner thanked the Workgroup for their participation this week.
