ESm provided a brief explanation behind the 'Comments' associated to this Change Proposal, outlining that of the 4 representations received, 2 were in support and 2 did not support implementation. Of the 2 that were not in support, 1 has subsequently indicated that they had changed their view and would support the Change Proposal. ESm explained that the document would be updated accordingly.

When it was suggested that as the Change Proposal should await SPAA approval before being included in the release, ESm responded by explaining that the 'sponsor' is already taking the matter to SPAA and furthermore, the Change Proposal is ready to go. Xoserve are of the view that progression of this Change Proposal can continue with implementation on hold until the SPAA view is known.

Supporting this proposed approach, PD explained that Xoserve has already completed the design stage and could hold off on the build and thereafter look to include the Change Proposal within the November release (a view supported by those in attendance), subject to SPAA approval and any subsequent timing considerations.

ESm advised that whilst there are no direct NTS impacts (as the files go to Cadent) associated with this Change Proposal there are some reports that go to NTS to be mindful of.
