223.4 Consider New Non-Urgent Modifications

a) Modification 0621L - Amendments to Gas Transmission Charging Regime

PG offered Members the opportunity to defer consideration of this Modification to a meeting on the following day. However, Members were content to consider the Modification at this meeting.

CS introduced the Modification, summarising that the aim was for this Alternative Modification to be issued to Workgroup 0621 so that it could be included in the Workgroup Report.

CS explained that it is proposed to include historical contracts in the CWD calculation to prevent undue distortions between existing capacity holders and shippers purchasing new capacity.

RP asked for a clarification in the presentation concerning Annual Firm Entry capacity prices and what is intended – would this impact Entry Contracts but not Exit? CS confirmed that Exit Contracts are already included in the scope of Modification 0621 and this Alternative Modification was proposing to include Entry contracts in addition to Exit Contracts.

MH advised that he intended to contact the Proposer directly to discuss the provision of analysis and Legal Text.

For Modification 0621L, Members determined:

- It is not related to the Significant Code Review, by unanimous vote;
