Key Points/Decisions

- 1. Joint Office welcomed everyone to the meeting. She explained that the purpose of today's meeting is to consider the relevant objectives.
- 2. It was noted that the meeting was not quorate as there were no DNs present. In addition, Ofgem did not join the meeting.

- 4. No Pre-Mod discussion.
- 5. Workgroup went through the Workgroup Report Part I and considered the charging objectives first. Chris Shanley reminded the Workgroup that the table on page 31 summarised the responses for the relevant impact. Each relevant objective was considered in turn showing a consolidated view of the responses from each alternative Modification. The following sections of the Workgroup Report were also reviewed, discussed and amended following consideration:
 - Relevant Objectives both sets. These sections were amended to include Workgroup views and conclusions.

- Stakeholder objectives a set of desirable features agreed by the Gas Industry at the end of 2016 to be considered alongside the Relevant Objectives
 - Minimise Volatility
 - o Predictability
 - Stability of prices
 - o Fairness
 - Security
 - Network Efficiency.
- 6. Workgroup noted that the methodology for the forecasting in the enduring period needs to be monitored by the Charging Methodolgy Forum (NTSCMF) post-0621.
- 7. Some Workgroup participants suggested a further meeting may be needed after the Workgroup Report has been submitted to consider any new information and issues that may arise to mitigate the Final Modification Report being sent back to Workgroup by the Modification Panel. A consultation workshop will be considered. Supporting documents and background information could also be made available to support Industry to inform consultation responses in a similar way to previously provided by Ofgem. It was noted that the Workgroup Report will include links to supporting documents.

New Action 030518: 0501: National Grid to consider if a consultation workshop is needed to support industry through the consultation phase.

8. Workgroup reviewed the Consultation Template and suggested that the Modification Panel consider the inclusion of a question which asks if there is any new information that should be considered by Ofgem's Regulatory Impact Assessment? Workgroup were reminded that consultation responses to the Final Modification Report would not be summarised.

The Draft consultation template has been published and Workgroup participants to review the consultation Template.

- 9. Workgroup reviewed the section on Workgroup conclusions and considered if there were any analysis areas where there had been insufficient time to complete, which should be specifically flagged in the Workgroup Report. This included a robust and more detailed assessment of the impacts on Competition of the move from transition from interim to enduring
- 10. Workgroup reviewed the section titled Recommendations to Panel. The wording currently included is as follows: "Workgroup therefore asks Panel to consider whether the Workgroup report can be sent out for consultation".
