## 1. Introduction and Status Review

Opening the meeting, RH made reference to the UNC0653 presentation submitted by National Grid NTS late on the previous day. When asked, those in attendance agreed to consider the presentation (at short notice) at this meeting.

# 1.1. Approval of Minutes (05 June 2018)

# 1.2. Modifications with Ofgem

RH advised that UNC Modification 0636/A/B/C/D 'Updating the parameters for the NTS Optional Commodity Charge' is currently with Ofgem awaiting a decision.

Parties were asked to note that the Joint Office issued an email request for further

evidence on behalf of Ofgem on Friday 29 June 2018. When asked, RH confirmed that E Proffitt of the Major Energy Users Council (MEUC) was included on the Joint Office email distribution list. Workgroup briefly considered who else might find sight of this email useful, especially consumer representatives. RH confirmed that a copy of the email would be forwarded to J Nicholson of the Energy Intensive Users Group (EIUG).

# 2.1. Update on Long Term Revenue Forecasts

RH confirmed that no formal update has been submitted for consideration at today's meeting.

In referring to the two outstanding NTSCMF Actions 0601 and 0602, RH requested, and National Grid NTS agreed, to provide an update at the 01 August 2018 meeting.

#### 2.2. Discussion on EU preliminary and final consultations (0621)

When parties in attendance voiced their grave concerns about a lack of either an Ofgem representative in attendance at the meeting or an update, RH undertook an onscreen exercise to capture a series of questions and concerns, which it was requested, would be published under today's meeting page and forwarded to Ofgem with an accompanying request that someone from Ofgem attends the forthcoming 05 July 2018 Transmission Workgroup in order to provide an update and respond to the industry questions being posed. It was noted that currently R Dunne is down to attend the Transmission Workgroup meeting on behalf of Ofgem.<sup>23</sup>

As stated in the email from National Grid sent on 07 June 20128, EU preliminary consultation responses should be sent to the Joint office who will forward them on to National Grid.

If any NTSCMF Workgroup attendees have questions for Ofgem regarding the questions and concerns these should be sent directly to Ofgem, and copied into Joint Office.

# 6.1. Revenue Analysis for UNC 0621 Modifications Modeling (especially 0621B aspects)

When JCh requested provision of supporting assessment related information, CW agreed to discuss the matter offline after today's NTSCMF Workgroup meeting.

RH also advised that the Joint Office is currently working towards publication of some subtly amended legal text.

When asked why some of the consultation responses appear to have been amended post close-out, RH explained that when going through each response to formulate the FMR, JO sought clarity around the 3 respective representatives preferences (i.e. it was not 100% clear within the original submission). She clarified that no respondents sent in updates unless they were approached by the JO in this way.
