1. Introduction and Status Review

1.1. Apologies for Absence

2. Approval of proposed changes to the NDM Demand Estimation Methodology

BF explained that this is an additional meeting set up to review and approve a minor change to the Demand Estimation Methodology document.

FC informed the Committee that they had noticed a typo that meant that one of the Uplift factors was not documented correctly and this meeting was to review and approve an updated version of the Methodology document. She confirmed that a minor change has been made to paragraph 3.4.4 for the uplift value for SW making the value now 1.02 from 1.0.

The Committee voted unanimously in favour of the change for the proposed amendment to the Demand Estimation Methodology document

MP confirmed that the updated ALPs and DAFs would be published as part of a combined key messages note for the meetings held on 24 July 2018 and 09 August 2018.

3. Any Other Business

3.1. Closure of Filton weather station

MP mentioned that at the last meeting the potential closure of Filton weather station had been raised. He suggested that preparations for a new weather station for the SW need to be made given that the quarterly report from the Met Office issued last week confirms that Filton weather station is due to close. It was previously suggested that Yeovilton weather station might be an option.

Both JB and SBI advised that they could provide weather data from Yeovilton if required for the comparison analysis. MP advised that they would undertake the analysis and that an additional DESC meeting might be required to discuss the results, prior to the next DESC meeting currently planned for 08 October 2018.

New Action DESC 0801: Xoserve to analyse the relationship between the data for Yeovilton and Filton weather stations provided by the Members. The analysis to include 2 hourly temperature and 4 hourly speed data for up to 2 years.

3.2. UIG levels

JB requested more information in relation to the sharp negative drop in UIG levels noticed on Monday 06 August 2018. FC explained that Xoserve had looked at the data input and there were no obvious errors. She explained that the high summer reduction due to the factory fortnight closure ended on Friday 03 August 2018 and that from Monday a more normal level of summer allocation would be expected. She suggested that the negative fluctuation could be as a result of a general reduction in demand over the summer which may have influenced the model, if take-up was not as expected. DESC may want to re-consider their decision of whether a review of the holiday factor is needed in next year's model.
