Next Meeting Wednesday 06 March 2019

Key Points/Decisions

- 1. CS confirmed that Shell have not been in a position to raise the potential Shell Alternative as they have not been able to substantiate the need for an Alternative without the appropriate analysis. The Workgroup considered the current deadline to conclude the Workgroup Report on 06 March 2019 and the coinciding deadline for Alternatives. JT confirmed Ofgem's decision for the requested Workgroup Report extension is hoped to be provided verbally today or tomorrow.
- 2. The Workgroup considered the Workgroup Summary and the comments received from DH expressing concern that the Summary had not captured all topic discussions. PG asked DH to clarify which points were missing. DH referred to item 20 and the list of discussion topics provided to assist with drafting the Workgroup delivery plan if Ofgem were minded to provide an extension. PG confirmed the list was provided verbally and clarified yesterday in the proposed extended Workgroup schedule. The Workgroup approved the Summary for Thursday 28 February 2019.
- **3.** The Workgroup considered the Forecasted Contracted Capacity (FCC) and the treatment of closed sites. The Workgroup report captured the concerns with the distortion of prices if left in. Clarity of treatment was requested.
- **4.** The Workgroup considered Action 05-0403 and the forecasted data being used in the FCC Model and the FCC Values for the Interconnector. The Workgroup Report captured the concerns of the Workgroup within the Workgroup Report and the action was carried forward.
- 5. It was agreed that SC would provide a response to Action 02-0403 for the DNs via email.
- 6. The Workgroup considered the Postage Stamp method and the benefits of this compared to Capacity Weighted Distance (CWD), the pros and cons for each approach and the variance in relation to the OCC, Combined ASEP and storage discount. The Workgroup captured the key elements of the CWD and Postage Stamp approach within the Workgroup Report.
- **7.** The Workgroup considered the initial representation from Manx Utilities published at: <u>http://www.gasgovernance.co.uk/0678/Reps</u>. Workgroup noted the points raised.
- 8. National Grid advised the Workgroup that an amended Modification 0678 v3 is anticipated by close of play 05 March 2019. The amendments will be in relation to revenue profiling, target revenue recovery, and to cater for a mid-year effective date. The Workgroup expressed concern about the timeliness of these changes and the knock on impact this may have on revisions of the Alternatives. The Workgroup considered the remaining time to consider late changes, which they believed could require extensive discussion particularly when considering the relevant objectives. The Workgroup discussed the ability of other Proposers and Workgroup participants to consider the extent of changes and be able to provide commentary for the Workgroup Report. It was suggested that the Workgroup capture their assessment as best as they can on the current version of the Modifications that any amendments beyond this stage will not be re-assessed as there would be insufficient time to allow the Workgroup time to conclude the Workgroup Report.
- **9.** The Workgroup requested that the Workgroup Report reflects that the Legal text for National Grid's Modification will be provided following completion of the Workgroup Report but during the consultation period.
- **10.** AS clarified that dependent on the National Grid Modification 0678 amendments, ENI will be considering whether or not to withdraw 0678D.
- **11.** The Workgroup considered and captured commentary for the Relevant Objectives.
- **12.** The Workgroup discussed the ability to submit late comments for inclusion in the Workgroup Report and that any late comments submitted via email at this point cannot be appropriately assessed by the Workgroup for Workgroup Report commentary and that such late submissions will need to be considered during the consultation process.

- **13.** The Workgroup considered and captured comments relating to the FCC governance and the differences between some Modifications which propose that the FCC Methodology is inserted **into** the UNC whereas others propose it resides <u>under</u> the UNC, others are unclear. The Workgroup discussed the method for providing the FCC Methodology and which approach provided better transparency, greater regulatory oversight and stability and therefore better facilitating competition.
- **14.** The Workgroup considered the topics for discussion for 06 March 2019 Workgroup Meeting.
