TS suggested; To have a separate session (workshop facilitated by Xoserve, or Agenda item at start of next UiG workgroup) to 'map out' all of these Modifications to see which ones affect which area/class etc. This would hopefully identify if any Modifications have direct impact on another. I would suggest also having different MPRN scenarios and following them through some of the processes proposed to see whether there are any gaps where they drop out but shouldn't.

Fiona Cottam (FC) confirmed that from the Modifications addressing the classes, that this had been addressed within Action 0701 as detailed below in Section 6.

Rebecca Hailes (RH) confirmed that with regards to the Modifications impacting on one another and the MPRN scenarios that these areas would be added to the next agenda under the Any Other Business entitled 'Modifications alignment/Impacts/Scenario analysis'.

3. UIG Task Force

3.1. Review of UIG Task Force Recommendations Tracker
