

Reads in scope for MOD0700

- Larger Supply Points (EUC2-9) are not subject to Mod 0700 rules
- All Replacement and Opening meter readings [and readings with a non zero RTC] (for all EUCs) are not subject to Mod 0700 rules.

Scenario 1: First Read Accepted

*D = Read Date

Read Read Staging Submission All Reads Older than D+10 Rejected and marked as "F" Shipper **Submits** Batch of All reads that are within D+10 will wait for read validation. Reads 1. One read will be selected and in this scenario is accepted, all other reads are marked as assured.

F = Rejected

E = Pending for Upload

U = Uploaded/Accepted

A = Assured



Scenario 2: First Read Failed, Second Read Accepted

Read Read Staging Submission All Reads Older than D+10 Rejected and marked as "F" Shipper **Submits** Batch of All reads that are within D+10 will wait for read validation. Reads 1. The first selected read, fails read validation and marked as F (Rejected) The second selected read, has passed validation and marked as U (Accepted), all other reads marked as Assured

- U = Uploaded/Accepted
- A = Assured
- N = Not assured

Implementation Impacts to PARR reports

- Implementation date of MOD is the Saturday 28th September.
- Reads submitted after September 28th will be subject to the new read status. Therefore October's reports (reporting September performance) will be impacted.
- Given the timeframes of the MOD, its proposed that any necessary amendments are made by October to take effect in November's reports.

PARR Reports Recommendations

Read Performance Report

 To <u>include</u> Accepted (U) and Assured (A) reads, in order to fairly reflect read performance for Shippers submitting anything greater than daily batches

Meter Read Validity Monitoring Report

- To exclude new status, as the report purpose is to display only reject reads and the associated rejection code (where applicable)
- Reads that are Not Assured (N) do not have a rejection code and therefore cannot be reported
