#### 1.2. Pre-Modification Discussions

# 1.2.1. Modification 0699A – Incentivise Key Areas of Performance using additional UIG Charges. (RK)

Rhys Keally (RK) explained this Pre-Modification was due to be discussed at the Distribution Workgroup on 28 November 2019, and explained this was being proposed as an alternative to *Modification 0664 - Transfer of Sites with Low Valid Meter Reading Submission Performance from Classes 2 and 3 into Class 4.* RK explained that early drafts of Modification 0664 had charges in the solution, these had now been removed in later versions and he wished to keep these charges.

He added that he thought it was valuable to provide an overview of the content to the UIG Workgroup meeting to ensure they were also aware of the proposal. RH agreed and Workgroup requested more detail.

RK then overviewed the content of the presentation and drew attention to the main areas of the proposed changes which were in relation to two charges. He explained these charges were in relation to the long term predictability of the charging levels:

- UIG cost avoidance (through moving sites to Product Classes 2 & 3 without the will or capability to support reads) and
- UIG causation (through non-submission of reads in any Product Class) He then
  provided an example of the proposed formulas for the 'Avoided UIG Charge' and
  the 'Cause of UIG Charge'.

A general discussion then took place and both Richard Pomroy (RP) and Louise Hellyer (LH) had concerns over this process. RP asked if there would be the ability for a third party to interrupt the process and LH said the charges should be rate reflective. RK said the process was to mirror the charges to encourage the right behaviour and reflect the costs. RP said this area still needed to be clarified and LH agreed, as she had reservations regarding avoiding the meters in relation to the UIG rebate process.

RK said he would undertake further investigations and present the Modification again at the December UIG Workgroup meeting.
