There were no Pre-Modification discussions.

Rebecca Hailes (RH) Chair, explained that Modification 0669 - *Incentivise Read Submission Performance using additional Charges*, was in the process of being withdrawn by ScottishPower. RH said that she understood that discussions were presently taking place internally at British Gas regarding a possible adoption of this Modification. Rhys Kealley (RK) confirmed that once a decision had been made, British Gas would confirm their intention.

RH also wanted to draw the Workgroups attention to a change. Due to the very large number of Modifications presently being developed within the Distribution Workgroup, a decision had been made by the Joint Office that some Workgroups would need to be discussed following the UIG Workgroup meetings; starting after this meeting with Request 0706R - *Instances where Shippers can exit commercial agreements with an independent supplier.* She added that the forthcoming UIG Workgroup meeting dates would continue to be used in this manner. Workgroup accepted this was a pragmatic way forward.
