2. New Change Proposals - Initial Review (Approvals needed)

2.1 XRN5116 Domestic Report - Must Read Prenotification

This new Change Proposal is sponsored by British Gas.

Current Must Read processes impact IGT SSPs, however the current Domestic pre-notification report is only issued on a quarterly basis. Changing the frequency of this report to Monthly would support proactive activity around submitting reads for IGTs, in line with UNC Must Read obligations, in addition to reducing MRA activity for IGTs.

Change the frequency of the Domestic pre-notification report to Monthly.

Shipper Users will be expected to vote on whether this change should proceed to DSG and for Xoserve to initiate Capture.

The DSC Service Area 18: Provision of user reports and information. The Service Area funding split is Shipper – 34%, DNO – 53%, NTS – 7% & IGT – 6%. Committee to agree 100% Shipper funded.

2.2 XRN5120 MAP to UKL Monthly Comparison Service

This new Change Proposal is sponsored by E.ON

Meter Asset Providers have access to a best endeavours data reconciliation service of which a request has been received to make this an ongoing regular reconciliation.

Over the last year or so, the CDSP have been providing a service to Meter Asset Providers (MAPs) to compare their meter asset portfolio against UK Link systems and play back the submitted data (MAP ID, MRPN, SUPPLIER_ID, METER_SERIAL_NUMBER, METER_INSTALL_DATE) into specific 'pots' to outline where mismatches occur and reporting back were there mismatches are found.

Outlined are the 'pots' which are to become an enduring set of reporting for participating MAPs:

- 01 Where provided MPRN is valid, registered and provided MSN matches with the current installed asset on UKL
- 02 Where provided MPRN is valid, registered, but provided MSN doesn't match with the current installed asset but provided MSN matches with previous installed asset held on UKL
- 03 Where provided MPRN is valid, registered, but provided MSN doesn't match and provided MSN doesn't match with any previous asset held on UKL
- 04 Where provided MPRN is valid, unregistered but provided MSN matches with the current installed asset on UKL
- 05 Where provided MPRN is valid, unregistered and the provided MSN does not match with the current installed asset on UKL
- 06 Where provided MPRN is not found in the UKL system
- 07 Where provided MPRN is not in the format of the Meter Point Reference Number

This Change Proposal is looking to enhance this reconciliation process making it a more formal ongoing Monthly service as a maximum frequency (but would also accommodate requests where customers wanted to participate quarterly or six monthly for example).

All Users will be expected to vote on whether this change should proceed to DSG and for Xoserve to initiate Capture.

2.4 XRN5121 Supplier Portfolio Service

This new Change Proposal is sponsored by Xoserve

As part of the Data Permissions Matrix (DPM) Suppliers are able to receive a portfolio report however it has not yet been created. This Change Proposal is to create the portfolio report.

As part of the Data Permissions Matrix (DPM) Suppliers can access a variety of data items if the Supply Meter Point is within their portfolio. As a result, several requests have been received by Suppliers to access this information. This Change Proposal is looking to develop a portfolio service to be provided to Suppliers via a Commercial Contract.

This is an opportunity for cost of the development of the Supplier Portfolio Report to be socialized across the Shipper community.

Shipper Users will be expected to vote on whether this change should proceed to DSG and for Xoserve to initiate Capture.

Service Area: None expected to be impacted. New service to Suppliers, suppliers do not form part of DSC customer base and data transfers to non-DSC customers are covered under existing service lines.

2.5 XRN5122 Gemini System Enhancements - Delivery

This new Change Proposal is sponsored by National Grid

The Gemini IT system underpins the commercial gas transmission regime and accounts for all capacity and energy transactions. It is owned by NGG with technical support provided by Xoserve under the Data Services Contract.

NG have a commitment to our customers and Ofgem to maintain compliance with the UNC and ensure that Gemini meets the needs of its users. Gemini Re-Platforming addresses the ageing hardware and brings the software versions back in support. Enhancements along with the longer-term roadmap is about adapting/improving Gemini based on the needs of a changing industry to meet customer expectations.

Change Proposal CP4632 carried out a Feasibility and Analysis (F&A) of a number of potential Gemini Enhancements that were based on feedback from customers. The output of the F&A was the Change, Business Requirements and Solution document (CBRS) and corresponding delivery options.

The purpose of this Change Proposal is to request Xoserve to deliver a set of the requirements captured in the CBRS; key activities to include the following:

- Detailed analysis of the selected enhancements
- Engage with shippers and other Gemini users to clarify those enhancements where assumptions were made under the F&A
- Define solutions for the in-scope enhancements
- Provide delivery options, including costs, complexity and timescales, taking into consideration the wider Gemini change programme
- Deliver the chosen delivery option
