267.8 Consider Variation Requests

a) Modification 0730 - COVID-19 Capacity Retention Process

The Proposer (SM) provided an explanation of the variation advising that it introduces a claims validation process as a Business Rule where previously, this was added as an avoidance of doubt statement in the Final Modification Report.

TS added that the avoidance of doubt question was previously only added to the Draft Modification Report and not followed up with an amendment to the Modification by the Proposer.

PG explained there will be two things for Panel to consider should the Variation Request be considered material:

- 1. Issue to Consultation
- 2. Return to Workgroup with a report provided to Panel in February 2021.

SM advised that Ofgem noted they would like to see further evidence of the likely utilisation of Modification 0730, now 0730V, and suggested, if this is issued to Consultation, the following questions are included in the Consultation:

The likely utilisation of Modification 0730V based on a National Lockdown

- 1. Aggregate number of Supply Points in Scope
- 2. Aggregate volume (kWh)
- 3. % of Supply Points where the relief from Modification 730V would pass directly to the Customer (i.e. pass-through contracts)

ER then provided a brief synopsis of the validation process in response to Panel Action 11/03 where additional information was requested for Panel to consider in relation to parties qualifying for Modification 0730.

ER stated that limited information is available to Xoserve at present and they have only been able to provide a very broad spectrum of potential outcomes to be calculated: at one end of the spectrum were 5 confirmed sites, with an overall isolation amount of £108.00 while at the other end, there could be up to 4,500 sites with an overall isolation amount of £28,000.

ER also advised that Xoserve are unable to provide any reliable view with respect to the materiality of this Modification due to Xoserve only receiving a limited response to date related to sites isolated immediately following the Modification 0723 implementation and the nature, frequency and duration of future lockdowns is unknown.

Following the presentation by ER it was agreed that Panel Actions 11/03 and 11/04 were now **Closed**.

Panel Members were asked to consider if returning Modification 0730V to Workgroup would add any more value and were informed that the Workgroup Supplemental Report expressed a view that this Varied Modification should be issued to Consultation.

When NB asked for clarification on how the process would work, TS advised this is clearly defined in the Legal Text and added that regardless of what Tier a business is in and that business is mandated to close due to COVID-19, then the Business can apply for this process to be applied.

Panel members agreed that sending the Varied Modification back to Workgroup would not add any further value.

Panel members were asked to consider if the Variation is material or immaterial.

Panel Members then determined (14 Panel votes were available for the determinations):

- The Variation Request is material, by unanimous vote (14 out of 14)
- It is not related to the Significant Code Review, by unanimous vote (14 out of 14).
- The criteria for Self-Governance are not met as the Modification does have a material impact on competition between Shippers and the allocation of Transportation charges, by unanimous vote (14 out of 14).
- Should be issued to consultation with a close out date of 12 January 2021, by unanimous vote (14 out of 14).

R Cailes (RC) provided an overview of the purpose for the Modification and explained the Association of Independent Gas Transporters (AIGT) no longer exists and since early 2020 has been amalgamated into the newly formed Independent Networks Association (INA) which includes both Independent Gas and Electricity Network business.

It was confirmed that there is currently an IGT Modification that should address a similar issue in the IGT UNC, therefore there are no Cross Code issues..

RP confirmed that the Suggested Text provided by the proposer is suitable for implementation.

Panel Members then determined (14 Panel votes were available for the determinations).

For Modification 0747 Members determined (14 Panel votes were available for the determinations):

a) Consideration of Alternative Modifications and Preference Voting

BF provided an overview of the process for considering alternative Modifications and the use of a preference vote as a numeric value to support Panel discussions when providing analysis to Ofgem on which Modification would further the Relevant Objectives the most.

SM mentioned that if there are more than two alternatives this process does not work very well; he suggested a different process for multiple alternatives.

RP said that when there are multiple alternatives it can be quite difficult to choose a preference, often there can be some Panel Members that do not have the required knowledge on the topic.

TS advised she does not like only being able to have one preference vote and would prefer being able to either abstain or choose multiple alternatives.

HC reminded Panel of the question that is actually being asked, reminding there needs to be consideration of the language used and a proper line of questioning should be adopted. e.g. do not ask a question "could Modification xxxx be implemented" as at this stage in the process, this should already be understood and Panel would manage the process accordingly.

It was noted that questions should be referring to which Modification best furthers the Relevant Objectives.

When asked, LK referred to Modification 0678 and its many alternatives noting that many of the alternatives could be clustered into similar solutions, whereas the preference voting method used at the time did not give Panel members the opportunity to reflect this.

PG advised that to take this forward, that BF,DF, LK and PG will discuss some potential options and report back to the February Panel.
