Background

Accuracy of By-Pass flag & status:

- PAC concerned with accuracy of Meter By-Pass status on UKLink
- Shippers asked to review affected MPRs in their portfolio and correct where necessary
- Datasets issued for 55 short codes on 9th October (request to investigate all sites with 'Open' and up to 5 sites with 'Closed' status)

Consumption Adjustments:

- General absence of Consumption Adjustments following period of 'Open' By-Pass
- Xoserve now actively chasing outstanding CA's directly with relevant shipper(s)
- Related Actions:
 - PAC Action 0101: Xoserve to explain what cross checks are done for Meter By-pass consumption
 - PAC Action 0102: Xoserve to identify the number of sites where there is an Open Meter By-Pass and evidence of consumption to allow these to be investigated
 - PAC Action 0103: Xoserve provide an Age profile for all Open Meter By-Pass sites

By-Pass Flag and Status Update

 Table below shows movements in Meters with By-Pass as recorded on UKLink

- Shipper By-Pass updates evident by continuing movements in numbers
- Significant reduction of 28 at 'Open' status since Jan'21 (26 of which are now at 'Closed' status)

By-Pass Consumption Adjustments

- Following a period of 'Open' By-Pass and if the 15 business day submission period has expired, Xoserve email shipper(s) to obtain positive confirmation on whether Consumption Adjustment is due
- First batch of emails issued 1st Feb 2021 (5 MPRs & 9 Shippers)
- Has prompted some activity but (as of 5th Feb) no definitive responses have been received (probably too early)
- Further emails due for 28 MPRs identified in Feb'21, assuming CA hasn't been received by the submission deadline

Action 0101: Cons. Adj. Validation

- PAC Action 0101: Xoserve to explain what cross checks are done for Meter By-pass consumption
- This action relates to the consumption value provided for Consumption Adjustments to account for gas consumed but not recorded on the meter during the 'Open' By-Pass period
- Market Breaker Tolerance is applied to consumption provided on each Consumption Adjustment, as per 'UNC Validation Rules' document available at https://www.gasgovernance.co.uk/tpddocs


Action 0102: 'Open' By-Pass with prog readings

- PAC Action 0102: Xoserve to identify the number of sites where there
 is an Open Meter By-Pass and evidence of consumption to allow these
 to be investigated
- On 1st February 2021 there were 119 sites with 'Open' By-Pass status
- Non-estimated Meter reads from UKLink (within the 'Open' By-Pass period) were assessed to give the following breakdown
