Ofgem's decision was to approve UNC728B: 'Introduction of Conditional Discount for Avoiding Inefficient Bypass of the NTS with 28km distance cap' for implementation on 1 October 2021. RHa added that the UNC Modification consultation had closed on 05 May 2021, one representation had been received and that the UNC Modification Panel would be considering the Final Modification Report on 13 May 2021.

RIIO-2 PCFM Guidance

Ofgem invited views on their draft of the RIIO-2 PCFM Guidance Documents and Revenue workbooks for the Gas Distribution, Gas Transmission, Electricity Transmission and Electricity System Operator licensees.

The proposed drafts set out guidance and instructions to help licensees update the variable values in the Price Control Financial Model (PCFM) for the first Annual Iteration Process submission as well as the reporting templates, which licensees need to fill out to calculate some of these variable values.

These documents are working drafts, the contents of which is in line with Ofgem's Final Determinations and licence modifications. Ofgem will ensure that all comments received will be appropriately reflected within the final version and will take effect by 01 June 2021. These documents should be considered in conjunction with the RIIO-2 special licence conditions and Price Control Financial Instruments, which is being consulted on for snagging modifications following the publication on 03 February 2021.

Anna Shrigley (ASh) also raised concerns with the expected decision date for Modification 0739 - Aggregate overrun regime for Original Capacity held at the Bacton ASEPs, as contracts for the winter were now being considered and the delivery of the Modification decision in August would be too late, ASh asked Ofgem to consider providing a decision as soon as possible. Sinead Obeng (SO) also expressed concerns about the anticipated decision date.

1.5. Pre-Modification discussions

Anna Stankiewicz (ASt) wished to advise that National Grid intends to raise a Fast Track Modification to update Section B licence references which changed on the 01 April.

2. European Codes Update

Phil Hobbins (PH) provided a brief EU Update for the EU Hydrogen & Gas Decarbonisation Package. PH confirmed that the EC is reviewing the Gas Directive 2009/73/EC and Gas Regulation (EC) No 715/2009. This is a public consultation on the revision and was launched late March, closing mid-June 2021.

The aim of the consultation is to evaluate the relevant gas market rules and, in particular, what reforms may be needed to reach the EU decarbonisation targets. The feedback from the consultation will inform the Commission's preparations of legislative proposals for a new hydrogen and gas markets decarbonisation package. These proposals are expected to be produced before the end of 2021.

6.1. Overruns Oct 2020 - Oct 2021

Anna Stankiewicz (ASt) provided an update on the October 2020 to February 2021 Overruns, providing an additional month's data. It was observed that similar data had been seen in February to that seen in January.

ASt observed that the costs of overruns were much higher although quantities had not increased dramatically, and questioned if the overrun multiplier needed to be reconsidered. Currently the multiplier was 3, it was suggested that a multiplier of around 1.5 may be more appropriate.

Nick Wye (NW) acknowledged that the increased cost in overruns was anticipated and suggested the Workgroup should establish a time to properly review the overrun multiplier.

Jennifer Randall (JR) confirmed the intention to review this in October once the arrangements had been in place for one year. The Workgroup welcomed a review of the overrun multiplier at the next 0705R Workgroup meeting in June.
