KE reported that this Modification had been rejected by Ofgem on 21 January 2022. Tracey Saunders (TS) advised that there were two areas of concern that prevented Ofgem approving the Modification which related to the approval of derogations and the Health & Safety approval. TS confirmed the intention will be to raise another Modification removing and replacing these elements with a view to process the replacement Modification with a shortened timescale. KE explained the options for pre-modification discussions and either referring the Modification to a Workgroup for one month to consider the different elements or the possibility of the Modification being issued directly to consultation. KE suggested on the submission of the replacement Modification TS may wish to use change marking on the original Modification to make it clear which elements had been changed.
