



Meter By-Pass Update

PAC Meeting - 15th March 2022

Background

Accuracy of By-Pass flag & status:

- PAC concerned with accuracy of Meter By-Pass status on UKLink
- Shippers were asked to review affected MPRs in their portfolio and correct where necessary
- Datasets issued for 55 short codes in October 2020 (request to investigate all sites with 'Open' and up to 5 sites with 'Closed' status)
- Further analysis identified 106 MPRs at 'Open' status but with evidence of progressing reads – issued to shippers in March'21 for investigation

By-Pass Consumption Adjustments:

- General absence of Consumption Adjustments (CA) following period of 'Open' By-Pass
- CDSP now actively chasing outstanding CA's directly with relevant shipper(s)

By-Pass Flag and Status Update

- Reduction in meters recorded on 'Open' & 'Closed' By-Pass status continues

Open Status & Progressing Readings: Background

- In March'21 Correla identified 106 meters with an 'Open' By-Pass flag on UKLink but progressing 'Actual' meter readings (likely indicator of incorrect status)
- Datasets were issued to affected shippers requesting investigation and (where appropriate) to correct the suspected incorrect By-Pass status on UKLink
- As of Feb'22, 69 of the 106 meters originally identified had been corrected leaving 37 remaining at 'Open' status
- At the Feb'22 meeting, PAC requested a further attempt to engage with shippers to address the remaining 37 meters (raised as action 0202 below)
 - **PAC0202:** *Reference Meter By-Passes with an 'Open' flag status – CDSP (MA) to engage with the Meter Owners and their respective CAM's for the remaining 37 sites where there is an 'Open' status flag in order to ascertain whether these can be resolved*

Open Status & Progressing Readings: Progress

- Revised datasets issued to affected (14) shippers on 23rd Feb'22
- As of 10th Mar'22, By-Pass status corrections for a further 8 (of the 37 outstanding) meters have been completed (with notification of a further 14 expected)
- 3 of the 14 shippers failed to respond and there has been no change to the By-Pass status for the meters in their supply (7 MPRNs in total)
- Correla will continue to:
 - monitor remaining MPRs
 - engage with shippers as appropriate, including those yet to respond
 - provide support to shippers (where necessary)

Update on 106 meters at 'Open' status (but with progressing reads)

Current status (as of 10th March'22):

- By-Pass flag remains 'Open': 29
- By-Pass flag now 'Closed': 60
- By-Pass flag removed: 17

'Open' status for this dataset further reduced by 8 since previous month
(as a result of recent engagement as per PAC Action 0202)

By-Pass Consumption Adjustments

UNC Requirement (M2.4)

- When a By-Pass is 'Closed', shippers to submit a Consumption Adjustment, where estimate is 10,000 kWh or greater, within 15 business days

Monitoring agreed by PAC

- CDSP to actively chase outstanding CA's directly with relevant shipper(s)
- Summary of requests for CA's following Open By-Pass and resulting outcomes are provided on next slide
