SECTION 2:

- Background: Provides relevant background information relating to the identified risk i.e. history, possible root causes, etc
- Recent and upcoming related industry activity: Provides details of recent and upcoming industry activity associated with the risk i.e. UNC Modification(s) and associated progress, industry workgroup meetings, government driven initiatives, etc
- **Recent PAC activity / mitigating actions:** Provides details of activities undertaken by or highlighted to the Performance Assurance Committee (PAC) including required next steps and any mitigating factors or actions that need to be undertaken
- **Relevant figures:** Provides either a text description of figures associated with the risk i.e. x volume of Supply Points for given period and where available a graphical illustration of data i.e. bar chart, pie chart, line chart, etc

Estimated value of risk (GBP) 000's would be added

- PAFA would strongly recommend that this entity is removed from the proposed new risk register.
- The existing PAFA Risk Model has no current capability and associated functionality to calculate any potential financial impact relating to an identified risk.
- The provision of data relating to potential financial ramifications for an identified risk would be a significant undertaking for PAFA to investigate and subsequently implement in terms of time, resource, effort and cost.
- There would be added complications in respect of how financial values (£) would be calculated i.e. what gas price would be used and when? i.e. SAP, SMP, Spot, etc. Other factors such as seasonality and the volatility of the gas market would complicate any framework put in place to calculate such financial risks
