GAS DISPOSAL TENDER INVITATION NOTICE

- This Gas Disposal Tender Invitation Notice ("Gas Disposal Tender Invitation Notice") is issued in accordance with, and is subject to, the Uniform Network Code (UNC), the Gas Disposal Tender Rules with reference number GDTR 1.0 (the "Gas Disposal Tender Rules") and the Gas Disposal Tender Terms with the reference number GDTT 1.0 (the "Gas Disposal Tender Terms").
- 2. Defined terms used in this Gas Disposal Tender Invitation Notice shall, unless the context otherwise requires or otherwise defined herein, have the meanings given to them in the Gas Disposal Tender Terms.
- 3. Users are invited to submit Bids in accordance with, and subject to, this Gas Disposal Tender Invitation Notice, the Gas Disposal Tender Rules and the Gas Disposal Tender Terms. Each of such Bids shall be for the purchase by the Tendering User from National Grid Gas of gas which is currently held in storage for Operating Margins purposes, pursuant to Section K of the UNC.
- 4. Each Bid is in respect of one only of the following Delivery Methods:
 - (a) by NBP Trade in accordance with the NBP 1997 Terms; or
 - (b) by Storage Gas Transfer in the Glenmavis LNG Storage Facility.
 - (c) by Storage Gas Transfer in the Partington LNG Storage Facility.
- 5. When a completed Gas Disposal Tender Bid Notice is submitted to National Grid Gas for delivery by Storage Gas Transfer, it must also be accompanied by written confirmation from the tenderer that they have an arrangement with the facility operator to receive and hold gas in store at Glenmavis or Partington effective for the period commencing 01st May 2009. National Grid Gas will then seek similar confirmation from the facility operator and if either confirmation is not forthcoming by 17:00 hours on 24th April 2009, the Bid will be treated by National Grid Gas as invalid.
- 6. Each Bid must also be in respect of a specific Delivery Period. Such Delivery Period is dependent on the Delivery Method and must be as per the following table:

- 7. Each Bid must be in respect of a whole number of Tranches, each Tranche being for a Tendered Quantity of 500,000 kWh of gas.
- 8. The Price in each Bid must be in pence per kWh and be to no more than four decimal places.
- 9. For the avoidance of doubt, users can submit multiple bids with each bid being in the format as stated above.
- The maximum aggregate quantity of gas which is currently in storage which National Grid Gas will be willing to enter into a Gas Disposal Contract pursuant to this Gas Disposal Tender Invitation Notice is 82,000,000kWh in total. This could be via NBP Trade or Storage Gas Transfer of 2,500,000kWh and 42,500,000kWh at Glenmavis and Partington respectively. National Grid Gas shall accept Bids in order of price in accordance with Section K 3.7.2(g) and (h) of UNC and Section K 3.7 generally. Furthermore 45,000,000kWh may instead be moved from one facility to another via the Swap tender (please our separate ITT to Trade) or as carry-across whereby the gas is withdrawn from one facility and injected into another rather than disposed of through this tender depending on the prices received. For the avoidance of doubt, National Grid Gas shall not accept Bids in aggregate for amounts exceeding such quantity.
- 11. The Bid Window Period within which Bids must be received by National Grid Gas is between 09:00 hours and 11:00 hours on Friday 24th April 2009.
- 12. Bids must be made in writing by completing in full the annexed Gas Disposal Tender Bid Notice and Schedule with the above Reference Number (or a direct copy thereof).
- 13. If National Grid Gas accepts, whether in whole or in part, a Bid, it shall use its reasonable endeavours to send a Gas Disposal Tender Acceptance to the relevant Tendering User in a Gas Disposal Tender Acceptance Notice no later than 17:00 hours on Friday 24th April 2009.
- 14. Gas Disposal Tender Bid Notices must be submitted to National Grid Gas by facsimile to facsimile number 01926 656613, marked for the attention of Sam Wither.
- 15. Any questions regarding this Gas Disposal Tender Invitation Notice may be made prior to the end of the Bid Window Period between 09:00 hours and
