RS asked, if this issues becomes a problem, can Users be updated asap so that the issue can be raised directly with iGTs

AM asked how Users should be contacted for information requests i.e. operational contacts or via a Joint Office mail out. RS suggested using both in order to help ensure the message is received. AM was concerned that there may be duplication within organisations but was willing to proceed on this basis.

AM confirmed that Xoserve is currently progressing a request for information from the AUGE, adding that the first draft AUG statement should be available by 1st May.
