#### 1.3. Review of Live Modification Proposals

BF summarised the current situation of all the live Modifications for the Distribution Workstream.

JD confirmed that Ofgem are considering the possibility of issuing an impact assessment for UNC0194/0194A.

BF highlighted that the energy related proposals Workstream had requested an extension for UNC0229 to enable further consideration. He confirmed the proposer's intention to provide a strawman on 15 January 2009.

JD confirmed that Ofgem have been approached regarding a view on UNC0232 for the reallocation of the charges through the Distribution Network Charges. He confirmed that Ofgem are considering the licence conditions and is hoping to provide a reply in January. It was confirmed that Ofgem will need to consider whether to reopen the price control review or hold until the next review.

#### 3.1. 014Dis, CSEP NExA agreements

ST confirmed no further update was available.

#### 3.2 025Dis, User Pays

JM confirmed that UNC0213V was out for consultation with suggested Legal Text, the consultation closing date is 06 February 2009.

## 3.3 031Dis, Maintenance of Best Practice Guidelines for gas and electricity network operator credit cover

JD was unable to report whether Ofgem will be leading a review. ST suggested that Transporters may raise a Review Proposal to enable a joint review with Ofgem and iGTs.

#### 3.4 032Dis, Primes & Subs

AS provided a presentation regarding the sub-deduct survey process. He confirmed that the letters are still to be finalised and that the process is likely to start April / May 2009.

RS asked about the labelling of sites. AS suggested that during the site survey process a note could be made of meters that are not labelled however he pointed out other opportunities for labelling meters which have been

identified without a label. ST suggested that this could be completed as a follow on exercise or as part of the survey process.

ST requested that all Shippers provide Transporters with a contact for the process. It was agreed that Shippers would provide at least one contact name, an email address and a telephone number. RM asked if each Transporter could also provide contact details.

RS questioned when draft letters would be available. ST suggested that consideration ought to be given whether to include the Transporter and Shipper contacts within the letter to ensure any contact made by the customer is targeted and avoid the possibility of some customers phoning a general enquiry line about the letter. It was agreed that the draft letters would be provided to the Joint Office to publish on the website.

It was agreed that 15 working days would be sufficient for Shippers to respond to the Transporters request for site contacts.

**Action 0102:** Transporters to provide Shippers with contact details for the sub-deduct survey process.

**Action 0103:** Draft sub-deduct survey letters to be provided and published on the Joint Office website.
