**Invitation to participate in the July 2012
NTS Exit (Flat) Capacity Annual Application Window**

Pursuant to both Section B3.2.26 and Section B3.4.1 of the Transportation Principal Document (TPD) of the Uniform Network Code (UNC), National Grid Gas plc ("National Grid") in its role as holder of the Gas Transportation Licence in respect of the National Transmission System (NTS) (the "Licence") invites you to take part in the July 2012 Annual Application Window for NTS Exit (Flat) Capacity. A separate notice has been sent to DNO Users in addition to this, detailing information on the OCS process and the DNO Adjustment window.

The Annual Application window will be held using the Gemini Exit Reform System (for the enduring exit period i.e. for 01 October 2012 onwards) and therefore all NTS (Flat) Capacity Applications and Reduction Notices will need to be entered in the Gemini Exit Reform System, for all Users including DNOs. For each NTS Exit Point (please refer to table one for details of valid NTS Exit Points) an Application (or Reduction) may be created, withdrawn or modified in line with the windows detailed in sections 1, 2 or 3 below.

Users are advised to familiarise themselves with the relevant sections of the UNC, the Exit Capacity Release (ExCR) Methodology Statement v7.0 and the Exit Capacity Substitution Methodology Statement v2.0 which can be found at www.nationalgrid.com/uk/Gas/charges/statements/.

A notice of the indicative charges for Enduring Annual NTS Exit (Flat) Capacity for October 2012 onwards has been published by National Grid, dated 1 May 2012, and can be viewed via <http://www.gasgovernance.co.uk/ntscharges/2012>

National Grid would like to highlight that any UNC modification proposals pending a decision from the Authority, or awaiting an implementation date, at the time of issuing this letter may impact the process for July 2012 Applications and Reduction Notices. It is for Users to determine for themselves the impact of any UNC changes, and any other changes to the exit capacity regime. However where a UNC Modification that impacts upon the July 2012 processes is implemented prior to 20th June 2012, we will communicate this to users.

We would also like to highlight that at the time of writing this invitation there are several outstanding NTS Gas Transportation Licence consultations. Where possible we have included the proposed changes within this document (indicated with *) to give individuals the opportunity to apply for Enduring Annual NTS (Flat) capacity, but where such changes introduce new NTS Exit Points into the Licence post 20th June 2012 then there will be insufficient opportunity to include them within this application window.

1. Annual Applications

The Annual Application Window will be open, as specified in TPD Section B3.1.9 of the UNC, commencing at 08:00 BST and ending on 17:00 BST on each Business Day in July.

Under TPD Section B3.4.2 of the UNC Users may make Applications for Annual NTS Exit (Flat) Capacity within the enduring exit period for Gas Years Y+1, Y+2 and Y+3. (i.e. Gas Years commencing on 1 October 2012, 1 October 2013 and 1 October 2014 respectively).

National Grid will inform each User which of its applications were accepted and the quantity of NTS Exit (Flat) Capacity allocated on the Gemini Exit Reform System by 8 August 2012.

the following information in respect of each NTS Exit Point for the Gas Years commencing 1 October 2012, 1 October 2013 and 1 October 2014.

- Aggregate volume of Annual NTS Exit (Flat) Capacity requested
- Aggregate volume of Annual NTS Exit (Flat) Capacity allocated
- Aggregate volume of Annual NTS Exit (Flat) Capacity unsold
- Total number of Users who submitted capacity requests
- Total number of Users who submitted successful capacity requests

For information, the remaining available Annual NTS Exit (Flat) Capacity for each relevant Gas Year in respect of each NTS Exit Point is shown in **Table One** attached to this invitation letter.

In accordance with the UNC TPD Section B3.4.2(c), the quantity of unsold Annual NTS Exit (Flat) Capacity made available for a full year shall be the amount of Remaining Available NTS Exit (Flat) Capacity that is available for all Gas Days within that Gas Year.

2. Enduring Annual Applications

The Annual Application Window will be open, as specified in TPD Section B3.1.9 of the UNC, commencing at 08:00 BST and ending at 17:00 BST on each Business Day in July 2011.

Users may apply for Enduring Annual NTS Exit (Flat) Capacity from Gas Years commencing 1 October 2015, 1 October 2016 and 1 October 2017 for those NTS Exit Points detailed in table 1 of this letter.

For information the quantity of remaining available Enduring Annual NTS Exit (Flat) Capacity for each month starting 1 October 2015, 2016 and 2017 in respect of each NTS Exit Point is shown in **Table Two** attached to this invitation letter.

Allocations of Enduring Annual NTS Exit (Flat) Capacity increase Applications shall be in accordance with the ExCR and will be published to Users by no later than 30 September 2012 on the Gemini Exit Reform System.

On the Day following the allocation of any applications National Grid will publish, on its website at <http://www.nationalgrid.com/uk/Gas/Data/excap/>, the following information in respect of each NTS Exit Point for each of the Gas Years commencing 1 October 2015, 1 October 2016 and 1 October 2017.

- Aggregate volume of Enduring Annual NTS Exit (Flat) Capacity requested
- Aggregate volume of Enduring Annual NTS Exit (Flat) Capacity allocated
- Aggregate Quantity of Enduring Annual NTS Exit (Flat) Capacity sold in excess of the Baseline NTS Exit (Flat) Capacity
- Total number of Users who submitted capacity applications

- Total number of Users who submitted successful capacity applications

3. Enduring Annual Reduction Notices

The Annual Reduction Window will be open, as specified in TPD Section B3.2.15 of the UNC, no earlier than 08:00 BST or later than 17:00 BST on each Business Day between 1 July 2012 and 15 July 2012 (inclusive).

National Grid will notify each User of the date on which the reduction is to be effective and the amount of Enduring Annual NTS Exit (Flat) Capacity that User will continue to be registered as holding, by no later than 30 September 2012 on the Gemini Exit Reform System.

In accordance with UNC TPD B3.2.24 and the ExCR, National Grid will, no later than twenty-four (24) hours after giving effect to a notice of reduction, publish on its website at <http://www.nationalgrid.com/uk/Gas/Data/excap/>, the following information in respect of each NTS Exit Point for each month where a notice of reduction was received.

- Aggregate amount of Enduring Annual NTS Exit (Flat) Capacity for which Users gave notices of reduction.
- Aggregate amount of Enduring Annual NTS Exit (Flat) Capacity which Users ceased to be registered as holding.

4. General

National Grid has put this document together with due care and in good faith to generally summarise the relevant process in each case but this Invitation is not intended to replace the more detailed provisions in UNC and the ExCR which Users should comply with.
