Update on Issues from Winter Preparation Group

MC updated the progress on this. There is now a standard Deed of Novation in place. Approximately 82% of the Deeds of Undertakings have been signed and returned. MC asked that members progress this in their own companies in order to further increase this percentage.

Review of Risk Register

Energy Balancing Credit Rules

Comments had been received from two parties and, as a result of these, LOS would be reissuing them. MC requested member to send a confirmatory email within a week of reissue

Emergency Cashout

The Transmission Workstream had requested EBCC participation in the ongoing discussions on changes to the way that cash-out prices would be set in a Network Gas Supply Emergency (NGSE).

Members expressed the view that the Workstream should not expect EBCC to provide the answers to some of the major issues associated with a NGSE such as the increased exposure of individual Users when cash-out prices are high. It was particularly highlighted that rules in respect of Cash Calls would continue to be applied rigorously in order to protect other Users. MC pointed out that he expected greatly increased activity within his team in the event of a NGSE. There would be an increased number of Cash Calls, information might not be so readily obtainable and there would be an increased reliance on manual processes. However, his team had anticipated and planned for such an eventuality.

MC was asked to attend the Transmission Workstream and explain, as necessary, the relevant credit control processes applied on behalf of all Users. MC agreed to fulfil this role on EBCC's behalf.
