#### **Credit Rules**

xoserve had circulated draft Version 3.6 of the Credit Rules that incorporated changes resulting from approval of Modification 0143 "Reduction of lapse periods in respect of Failure Notices issued in respect of Energy Balancing Credit"

A discussion was held on the document and MC agreed to update the draft accordingly and recirculate for approval by members. Once approved, it would be placed on the Joint Office of Gas Transporters website.

#### **AOB**

There were two further Modification Proposals of interest to the Committee:

# 0171 "Amendment of "User SP Aggregate Reconciliation Proportion" to incorporate historical AQ Proportions"

The November UNC Panel meeting had referred this Proposal to the Distribution Workstream which would be meeting on 22 November 2007.

## 0181 "Scheduling Charges calculation for Gas Flow Days 22, 23, 24, 25 & 26 October 2007"

The November UNC Panel had not recommended implementation of this Proposal. It is currently with Ofgem for determination.

MC gave a presentation that set out the Termination and Discontinuance processes. After discussion, MC agreed to investigate ways in which Supplier Undertakings could be obtained from existing Shippers as part of the security renewal process Action MC
