

Mod 0600S - Amend obligation for the acceptance of EPDQD revisions made after D +5

Context

- UNC states no revisions to the EPDQD will be made after D+5
- National Grid NTS accepting late revisions to ensure accurate shipper allocations
- If late revisions no longer accepted, will have adverse impact on shipper allocations
- Therefore UNC needs to be aligned to reflect current practices
- Current proposed revision of obligation, so EPDQD amendments can be accepted after D+5, but inclusion of new reporting obligation for late amendments



Issues Raised at November Workgroup

- Differences between National Grid and CVA data for revisions submitted after D+5
- When do the majority of revisions fall between D+5 and M+15
- Further engagement with sub-terminals



Data for revisions submitted after D+5

- Number of sub-terminals state identified late revisions were not made by them
- CVA to provide monthly report to NG of late revisions so NG can investigate each occurrence
- CVA and NG to arrange bi-annual meetings to discuss continuous improvement opportunities and discuss issues
- Further analysis required to understand cause of late revisions, differences in data and sub terminal perspective
- Misalignment of CVA and NG systems and processes need further investigation

Engagement with sub-terminals

- Obtain feedback from sub-terminals on:
 - Proposed solution
 - Reasons for late amendments
 - Amending the NEAs
- Will discuss EPDQD at Annual Liaison Visits
 - Face to face meeting between NG & sub-terminals to discuss operational topics
 - Begin in November 2016



Current Proposed Solution

UNC Change:

- Amend E 1.4.2 of UNC, so EPDQD amendments submitted between D +5 & 10:00 on M+15 can continue to be accepted
- But any post-D+5 amendment would be reported on the National Grid website
- Report would contain following details: site name, relevant gas day, reason for late amendment

Non-UNC Change:

- Update generic NEA template
- When existing contracts opened for amendments include EPDQD revisions
- Write to all system entry points to inform them of change to code, and requirements upon them which would ensure acceptance of their late revisions

Revised Solution

- If sub-terminals unaware of late revisions being made, reporting obligation would not be effective
- Initial CVA engagement with sub-terminals they will not provide additional information without NEA changes
- Key priorities:
 - Facilitate acceptance of late revisions
 - NG compliance with UNC
 - Align CVA and NG data of late amendments
- Discussed alternative ways to resolve issue will review and propose amended solution at January Workgroup
