Notice of NTS Exit Capacity Charges ahead of the 2009 Application window for Enduring Annual NTS Exit (Flat) Capacity

The Uniform Network Code (UNC) requires that annual application windows for Enduring Annual NTS Exit (Flat) Capacity be held every July. Consistent with industry practice, National Grid NTS is giving two months notice of the Indicative NTS Exit Capacity Charges ahead of the July application window. The charges relate to the first capacity year of Enduring Annual NTS Exit (Flat) Capacity, 2012/13.

Please note that the charges attached along with this note are indicative. Actual charges will be based on the prevailing Exit Capacity Charges for 2012/13 as stated in the Transportation Statement, 1st October 2012, which will be published with 2 months notice.

The Expansion Constant used to set charges for the July 2009 application window equals £2437/GWhkm. This will remain fixed for the actual Exit Capacity year 2012/13. Other inputs to the model are subject to variation.

For further information on how these charges were calculated please refer to the <u>Statement of Gas</u> <u>Transmission Charging Methodology</u>.

It is our attention to send out the Transportation Model used to create the attached charges to registered users. This will allow you to familiarise yourself with how potential variations in inputs to the model may affect actual charges.
