

FGO – Review of IGTAD

The table below identifies:

- the types of information to be provided and received by the 'Agency Company' (as specified in IGTTAD, ie xoserve) on behalf of the DNOs and IGTs and the circumstances in which the information is provided and received, for the purpose of identifying what services the CDSP will be performing for the DNOs and IGTs under the IGTAD. In general CDSP services under the IGTAD are 'Agency Services' within the new GTB7.
- amendments to existing provisions of IGTAD to reflect the creation of the CDSP and the DSC.
