- If approved by UNC Panel, consultation expected to begin straight away

# **FGO Modification Proposals**

- Modification Proposal 0565 Raised by National Grid Distribution Ltd.
  - Original Modification defining changes to be made to move from Transporters' Agency to Central Data Service Provider. Proposed Transporter voting arrangements (1 NTS, 3 DNs and 2 iGTs)
- Modification Proposal 0565A Same as 0565 except:
  - Variation on Transporter voting for proposed Change and Contract committees. 2 NTS, 2 DNs and 2 iGTs
- Modification Proposal 0565B Same as 0565 except:
  - Variation on Transporter voting for proposed Change and Contract committees. 1 NTS, 4 DNs and 1 iGTs

# Modifications 0565 / 0565A / 0565B purpose

- Define Central Data Services Provider (CDSP)
- Introduce the Data Services
   Contract (DSC) as a code
   referenced document
- Obligation for all UNC Parties to accede to and comply with the DSC
- Obligation for all parties to jointly control and govern the CDSP
- Obligation for all parties to procure the use of the relevant CDSP Services

- Obligation for all parties to pay for CDSP Services in accordance with the CDSP Charging Statement
- Reallocate contractual obligation for the provision of services
- Introduce new Modification Rules to define roles and responsibilities for the interaction with the CDSP
- Define transitional terms to cover period from CDSP implementation to Nexus

## **Key UNC Changes**

- General Terms: New Section D CDSP and UK-Link
  - Drafted on the basis of post Nexus legal text
  - DSC Transitional Arrangements document to override or vary GT Section D until such time as Nexus has gone live
- Changes to TPD Sections G (Supply Points), H
   (Demand Estimation and Forecasting) and M (Supply Point Metering) will be made against pre-Nexus UNC
- Changes to other GT and TPD Sections will be drafted on the basis of Post-Nexus text
- Changes to the IGTAD will reflect a post-Nexus nature

Identification of Agency Functions for the CDSP

#### Section E (Daily Quantities, Imbalances and Reconciliation)

- Definition of Direct and Agency functions
- Redirection of obligations from Transporters to CDSP



## **Transporter Principal Document**

#### Section F (System Clearing, Balancing Charges and Neutrality)

Confirmation of Agency Functions

#### Section G (Supply Points)

• Definition of CDSP functions (e.g. determining AQs, maintaining the Supply Point Register (SPR) and undertaking query management in respect of the SPR

#### Section H (Demand Estimation and Forecasting)

• Identification of Direct and Agency definitions for DE / DF services.

#### Section M (Supply Point Metering)

- Identification of Direct Functions
- Removal of references to User Pays Services

#### Section Q (Emergencies)

 Definition of Agency Services relating to the recording of emergency contact details and the management of post-emergency claims validation processes.

#### Section S (Invoicing and Payment)

- Identification of Agency definitions for these services.
  - Notifying Users of invoice timing
  - Calculating invoice amounts
  - Submitting invoice documents
  - Resolving invoice queries

- Definition of Direct and Agency Services
- Requirement for Users to accede to the DSC
- Requirements for Trader Users
- Refinement of Defaulting User definitions to require parties to comply with the DSC
- Liabilities to be managed via the DSC

#### Section X (Energy Balancing Credit Management)

- Confirmation of Agency functions
- Confirmation of ring-fencing of CDSP Credit Committee from EBCC

## **Offtake Arrangements Document**

#### Section M (Data Flows)

 Replacement of references to the Agency Services Agreement (ASA) with the Data Services Contract (DSC)

#### Section N (General)

- Requirement for New DNOs to sign the Accession Agreement and meet its requirements
- Requirement for withdrawing DNOs to satisfy the DSC's withdrawal requirements

# Independent Gas Transporters Arrangements Document (IGTAD)

#### Section A (Scope and Classification)

 Confirmation that IGT Services will be delivered under the same Agency Services umbrella as GT Services

#### Sections B, D and E

Primarily replacing Agency with CDSP and arrangements with DSC

#### Section F (General)

- Requirement for new IGTs to accede to CDSP arrangements
- Requirement for withdrawing IGTs to satisfy DSC withdrawal arrangements

#### **Modification Rules**

#### General inclusion of the CDSP to better inform Modifications

- CDSP can raise Modification Proposals to amend the DSC in specific cases
- CDSP can make representations as to whether or not a Modification should be a Self-Governance Modification Proposal
- Remove references to User Pays
- Define the interaction between the CDSP and the Change Committee

#### TD Part 1: General

 Defines the terms included in the Transition Document

#### General Terms: Section C

 Excludes the CDSP from being treated like an affiliate.

#### New Section D (CDSP and UK Link)

- Provisions and objectives relating to the CDSP and CDSP Services
- Requirements and obligations in respect of the Data Services Contract (DSC)
- CDSP will be "Not for Profit". Costs will be met by its customers
- The introduction of Direct and Agency Services
- References to the relevant Licence Conditions
- The establishment of Change, Contract and Credit Control committees
- High level Budget and Charging methodologies
- The introduction of a Credit Policy for CDSP services
- Appeal Procedures

- Review the accompanying DSC documentation with a view to being able to sign it in advance of the FGO Implementation Date
- Identify and nominate Change and Contract Committee members
- Get involved with the development of Xoserve's BP17
