1 Summary

Is this a Self-Governance Modification?

The Modification Panel determined that this is a self-governance modification because it is unlikely to have a material impact on any party as it is simply aligning the UNC Modification Rules to Ofgem's decision, to replace the Gas Forum with the Joint Office as the 'Designated Person'.

Is this a Fast Track Self-Governance Modification?

The Modification Panel determined that this modification should be classed as fast track self-governance as it is a housekeeping modification to deal with a factual name change only.

Why Change?

The 'Designated Person' is the individual who performs the User Representative UNC Panel and subcommittee appointment process on behalf of Users. The 'company secretary of the Gas Forum', who previously performed this activity, is no longer available because the Gas Forum has ceased trading. On 01 March 2016 Ofgem's decision was for the Joint Office of Gas Transporters (the Joint Office) to be the new 'Designated Person'.

Solution

The UNC Modification Rules defined term of 'Designated Person' will be updated to identify the 'Chief Executive of the Joint Office of Gas Transporters'.

Relevant Objectives

The Proposer believes this modification meets relevant objective f) Promotion of efficiency in the implementation and administration of the Code, as it ensures code is updated to reflect the correct 'Designated Person' information.

Implementation

As fast track self-governance procedures are proposed, implementation could be sixteen business days after a unanimous vote in favour of implementation by the UNC Modification Panel, subject to no objection being raised.

Does this modification impact a Significant Code Review (SCR) or other significant industry change projects, if so, how?

2 Why Change?

Annually, UNC Modification Panel members (who automatically become UNC Committee members) and UNC Sub-committee members are nominated, elected and appointed using the UNC Modification Panel & Sub-Committee – User Representatives Appointment Process. Historically, the administration role was performed by the Gas Forum, with the 'company secretary of the Gas Forum' being the Designated Person. As notified on 03 February 2016, the Gas Forum ceased to operate from 01 January 2016. As a result a new 'Designated Person' needed to be appointed by Ofgem to operate the appointment process.

On 01 March 2016, Ofgem appointed the Joint Office of Gas Transporters to be the new 'Designated Person'. Its decision being that it was consistent for the code administrator to carry out this role on behalf of Users.

This proposal seeks to update the UNC Modification Rules to ensure the 'Designated Person' reflects Ofgem's decision.

3 Solution

As per the previous code requirement the 'Designated Person' is an individual, rather than an organisation. Therefore the company secretary of the Gas Forum, is replaced by the Chief Executive of the Joint Office of Gas Transporters. A change to the UNC Modification Rules defined term 'Designated Person' is required.

- subject to (b) below, the individual for the time being appointed as the company secretary of the Gas Forum (a company incorporated in England and Wales, with company registration number 2941152); Chief Executive of the Joint Office of Gas Transporters; or
- (b) any other individual of whose identity the Panel Chairperson may be notified by the Authority;

- (b) any other individual of whose identity the Panel Chairperson may be notified by the Authority;

The Panel Chair summarised that Modification 0579FT proposes to update the UNC Modification Rules to ensure that the definition for the 'Designated Person' reflects Ofgem's decision to appoint the Joint Office as the Designated Person for appointing User representatives to Panel and UNC Sub-committees.

Consideration of Relevant Objectives

Members considered relevant objective f), agreeing that implementation would have a positive impact on the efficient implementation and administration of the Code as it would ensure that the definition for the 'Designated Person' contained within the UNC Modification Rules is amended commensurate with the previous Ofgem decision and thereby allow the Joint Office of Gas Transporters to appoint User representatives to Panel and UNC Sub-committees going forwards.
